V. Update on School Activities

Anita Fine

Gause – Ms. Fine did receive an email for the director of facilities asking if Compass board has decided and approved to move. Fine wrote back that she gave stipulations to Mr. Heid and she hasn't heard back from since February.

FSA – FSA Writing test was last week. Teachers were pleased on the students' efforts as well as their use of the time they were given.

Math Teacher – This is the math's teacher last week with us. She stated she is burnt out from teaching. She has been with Compass for 7 years, so it's disappointing to see her leave. She is leaving the teaching profession and going to work in a veterinary clinic. The position will be posted in Handshake, which distributes to the colleges, as well as the website.
