

# Beardstown Marina Mile 88 Project

## PROJECT GOALS

The Project Goals reflect the need for the main project initiative of dredging the access channel between the Illinois River and the Beardstown Marina. The goals also provide information as to how the overall Project may provide beneficial impacts to the City of Beardstown, the surrounding region, and the State of Illinois.

### **1. First Responder Access**

Currently, first responders have two access points to the Illinois River when required to retrieve sick and/or injured personnel from tow boats, recreational and/or commercial boat traffic which may include search and rescue activities. One access point is a gravel ramp which belongs to a local river tug service in Beardstown. The other access point is on the opposite side of the Illinois River in Schuyler County which is a 6 mile trip (one-way).

### **2. Environmental Impacts**

Asian carp have been in the Illinois River since the 1990's. By the year 2000, they started to reproduce rapidly. The fish can spawn four times each year. The Atlantic Capes Protein Plant, located in Beardstown, has provided an opportunity to assist in removal of this invasive species from the Illinois River ecosystem. The plant has also created jobs in the area which result in economic impacts. Improved access to the Illinois River would allow easier access for commercial fishermen.

### **3. Economic Impacts**

New revenue for the City of Beardstown and the surrounding region could be realized as a result of completing the project initiatives identified in the overall Project (i.e., sales tax and motor fuel taxes). In addition, users of the Marina facilities (camp ground, gas dock, boat ramps and slips, etc.) may frequent numerous other businesses including restaurants, boat shops, grocery stores, gas stations, and other tourism locations in the surrounding region. Re-establishing boat access to the Illinois River has the potential to increase the number of commercial fishermen to harvest Asian carp once reliable boat access is available. This provides both an economic and environmental benefit simultaneously to the City of Beardstown and the surrounding region.

### **4. Tourism and Recreation**

Residents of the City of Beardstown and the surrounding region, along with out-of-state tourists, may utilize the Illinois River in greater numbers for wildlife watching, hunting, fishing and water sports activities as the Beardstown Marina Mile 88 Project is developed. Currently in Cass County there are 798 registered boaters, 74 commercial fishing licenses and 1,075 fishing licenses (as of 06/19/2018).

### **Open Space Lands Acquisition and Development (OSLAD) Grant – Approved**

- River viewing stand/fishing dock (ADA accessible)

### **Capital Improvement Grants – Approved**

- Grant funds will be used to complete dredging around the northern end of the Marina. This will result in deeper waters around the boat launch ramps and also on the way out to the channel around the northern point of the Marina.
- Bids for the dredging work will be requested by the City in May 2019 with dredging scheduled to occur as soon as possible.

### **Additional funding opportunities being pursued for these project initiatives:**

- Fuel dock at the Marina for boaters
- Boat wash station
- Business advertising sign board at the Marina
- Kiosk at the Marina to allow patrons to pay parking, camping, and/or boat launching fees
- High water boat launching ramp
- Paving new parking area created at the Marina with the dredged access channel material
- Docks alongside the current boat launching ramps
- Docks and boat slips for short- and long-term boat parking and fire/rescue
- Fixed telescope at the Marina river viewing stand/fishing dock for eagle watching and wildlife viewing
