
# HISTORY IN THE MAKING

Upper Macungie Township is set to make history with the construction of its 188,000-square-foot Community Lifestyle Center at Grange Park. Over a decade of steps were taken by Upper Macungie Township before construction began in the Fall of 2024. The first section of heavy timber was erected in May 2025 which earned the project the distinction of being the first of its kind on the East Coast and the longest structural timber project in North America. In November 2025, the last beam was signed and placed.
