Re: Proposal for Investigation of the Alamo Cenotaph Monument

OVERVIEW

This Proposal is in reference to a request from Ms. Rosser and Mr. Butler for a proposal to provide Preservation services in relation to the Alamo Cenotaph Monument on Alamo Plaza in San Antonio, Texas. Architexas will employ a Structural Engineer and possibly a Stone Monument Consultant to complete this scope of services.

SCOPE OF SERVICES:

PHASE I – STATE OF TEXAS ANTIQUITIES PERMITTING AND AUTHORIZATION TO PROCEED

TASK 1 – ORIENTATION AND HISTORICAL RESEARCH - Review information provided by Client, collect available historic photos and drawings. Conduct a Project Orientation site visit.

TASK 2 – EVALUATION OF EXISTING CONDITIONS – To the extent of observations available from the ground and by aerial drone, Architexas will evaluate existing conditions and prepare a plan for necessary additional selective historic fabric removal to reveal hidden conditions and other testing, observations and research as needed. Assume 2 days of site visits.

TASK 3 – STATE ANTIQUITIES LANDMARK – Prepare a State Antiquities Landmark permit application. Meet with Texas Historical Commission staff to review the proposed investigative work, present application to the Texas Historical Commission's Antiquities Advisory Board and full Texas Historical Commission. Assume 3 meetings.

PHASE II - INVESTIGATION/SCOPE DETERMINATION

TASK 1 – INVESTIGATION – Conduct full Cenotaph Monument Investigation by Architexas, Structural Engineer and Monument Conservator. Access, lifts, scaffolding, dimensional stone and masonry removal and temporary protection or replacement will be provided by Client's General Contractor under Architexas' direction. Assume 6 days of on-site investigation.

TASK 2 – COST ESTIMATE – Produce an initial cost estimate for the cost of Monument's Preservation/Restoration based on the findings of the investigation.

TASK 3 – TESTING – Recommend additional testing required at this time, such as hazardous materials testing, scoping of drain lines, reinforcement scanning, mortar and stone compressive testing, etc.

TASK 4 – ANTIQUITIES COMPLETION REPORT – Prepare required Antiquities Completion Report in order to close out the Antiquities Permit secured in Phase I

COMPENSATION

Architexas agrees to the above Scope of Services for the Alamo Trust, Inc. for a fixed fee of \$19,600 for Phase I and \$76,100 for Phase II, plus reimbursable expenses, which we estimate to be \$2,500 plus Conservator Consultant expenses.

REIMBURSABLES

Expenses incurred in the interest of the project are not included in the compensation for professional fees, and include: Photographic supplies, printing, copying, postage, mileage, travel expenses (including rental car, lodging and meals), delivery expenses, specialty testing and Monument Conservator Consultant. Reimbursable expenses will be invoiced at 1.1 times the actual expense.
