1. About This Standard

Purpose

This document is to provide all Facilities, NetScience Staff, NetScience Athletes and Accompanying Guardians with guidance as to the NetScience Safe Operating Requirements for the COVID-19 restricted duration.

Scope

This Standard will comply with all Facility rules and will apply to NetScience Employees, NetScience Athletes and Accompanying Guardians.



CAUTION: Adherence to this Standard is essential for the Safety of all persons (employees, users and public) and the continued use of provided facilities. All incidents will be handled on a per case basis.

2. General

All Persons participating in a NetScience (Staff, Athlete or Guardian) must comply with the following health rules:

	Action
1.	Enter through the designated entrance (if supplied). <div style="border: 2px solid red; padding: 10px; margin: 10px 0;"><p>WARNING: Anyone who is sick or symptomatic must not enter the facility or participate in the game/activity. Participants, spectators, staff and volunteers should use the self-assessment tools for COVID-19, provided by the Government of Saskatchewan and follow the subsequent directions.</p></div>
2.	Physical distancing must always be maintained.
3.	Practice personal hygiene: Abstain from touching face (mouth, eyes, or nose), and cover a cough or sneeze with a tissue and throw the tissue in the trash.
4.	Spitting of any liquid or consumable product, including but not limited to sunflower seeds, gum, chewing tobacco or candy, is not permitted.
5.	The sharing of personal equipment is not permitted.
6.	Participants/players are responsible for cleaning and disinfecting their equipment/items after each use.

It is the responsibility of the NetScience Management to ensure all persons involved are aware of the rules of participation prior to entrance to the Facility.

3. Scheduling

Request Facilities

Information provided to the Facility when booking will be as follows:

Step	Action
7.	Type of Facility required (Ice surface, Field House, meeting room, fitness, etc.).
8.	Time requested for use.
9.	Space for Dressing Room(s) needed (if required). <div style="border: 2px solid orange; padding: 5px; margin: 5px 0;">  <p>CAUTION: Physical Distancing of 6 ft will be observed at all times. When scheduling use at a Facility, the space required will be calculated from the number of Athletes and Employees.</p> </div>
10.	Time required for use of Dressing Rooms (eg. 15min prior to and after Scheduled ice time).

The request for facility is complete.

Facility Confirmation

Once the Facility has confirmed scheduling, details of use will be provided:

11.	Type of facility booked (Ice surface, meeting room, fitness, etc.).
12.	Location of use (what ice surface, etc.)
13.	Cost of use.
14.	Which Dressing room(s) are to be used (if a dressing room is required).
15.	Entrance Access restrictions, if any.

The facility booking is now confirmed. The compliant use of these facilities is to be detailed in following sections.

4. Use of the Facility

NetScience Staff

NetScience Staff must observe requirements for Physical Distancing, use of Facilities, and the safe interaction with Athletes and Guardians.

16. **Arrive** a minimum of 10 minutes early to ensure the Facility has been prepared for use (Rooms empty, clean and disinfected).
17. **Submit** signed COVID HEALTH DECLARATION forms to NetScience staff lead.
18. **Maintain** physical distancing guidelines at all times.
19. **Obtain** signed COVID HEALTH DECLARATION forms from Athletes as they arrive (**daily**).



NOTE: Only staff and athletes are allowed in Lloydminster facilities at this time. Spectators are not allowed until further notice.



WARNING: Spectators not complying with Facility directives will be reminded immediately by NetScience staff. Non-compliance and removal will be the responsibility of the Facility Management.

20. **Comply** with Facility directives concerning equipment management.


NetScience Staff is aware of the guidelines and will comply with the COVID-19 rules regarding Facility use.

Athletes participating in NetScience activities are responsible to follow the guidelines in this standard outlined below:

| 22. | Present signed COVID HEALTH DECLARATION forms to NetScience staff upon entry to Facility (every day). |
| 23. | Apply hand sanitizer provided upon entry. |

| 25. | Maintain physical distancing guidelines at all times.

Athletes will always comply with this procedure or will be removed from NetScience activities for that day. Further infractions may result in expulsion from future events.

5. Instruction

On Ice Activity

NetScience on ice activities will be conducted to ensure COVID -19 compliance to ensure the health and safety of all participants including Staff.

27. Disinfect equipment (NetScience Staff).

28. **Disinfect** posts and crossbar of each net between each group activity.

29. **Place** water bottles on Player’s benches as directed by NetScience staff.

30. **Ensure** physical distancing measures are planned and discussed prior to on-ice activities.

With these measures in place, NetScience and Staff will ensure COVID-19 regulations are followed to the best of their ability.

Off-Ice Activities

NetScience off-ice activities (including Field Houses, Meeting Rooms, etc.) will be conducted to ensure COVID -19 compliance to ensure the health and safety of all participants including Staff.

31. Athletes will be placed in groups of 5 or less to ensure adequate distancing.

32. Training tools and equipment will be sanitized between groups.



NOTE: When practical, Athletes will be given their own equipment not be shared with others.

With these measures in place, NetScience and Staff will ensure COVID-19 regulations are followed to the best of their ability.
