In 2014, he handed the role of MD to Andrew Bewes but stayed on to develop their export business all around the world. He finally retired in 2017. He now has a flat in Madeira, where he spends much of his time. In 1966 he joined the Honourable Artillery Company, where he served for 5 years. In 1966 he joined the Worshipful Company of Pattenmakers and became Master in 1981.
