### TERMS and CONDITIONS (read carefully)

1. Space is not guaranteed and is subject to approval by the Coeur d'Alene Garden Club. Confirmation will be sent to vendors.
2. **Deadline is April 30, 2026.** Payment and this signed application & agreement must be received by the Garden Club by this date to hold your place. Payment is non-refundable unless vendor is not selected to participate.
3. Vendors agree to provide their merchandise during the entire course of the event. For the purpose of this event, the items which the vendor will be authorized to sell are defined as "garden related." Vendors must provide a sign with your business name at the space.
4. **Setup must occur between 7:30am and 9:30am on Tour Day, and Breakdown must take place from 4pm and 5pm on Tour Day.** If this is not enough time, please let the Vendor Chair know as soon as possible. Early dismantlement is not allowed. All trash and debris must be cleared from vendor area at event close.
5. Electricity is not available.
6. Vendors must be respectful and careful within the garden. Dumping of wastewater on the lawns is not permitted, nor is any other action likely to damage the property. No driving in the garden without express permission from the property owner.
7. Booth spaces are subject to change by the CDA Garden Club. The specific garden location will be determined by an appointed representative of the Garden Club. All sales merchandise **must be kept within each vendor's assigned space**. Walkways shall not be obstructed by merchandise. However, we have no objections to spread out "a little bit" beyond your allocated space.
8. Parking is limited to unloading and loading only; only one (1) vehicle at a time is permitted. Please use the designated vendor parking area.
9. This contract may not be assigned by the vendor to any other party, nor may the space or location be shared with any other party or vendor without express written approval of the CDA Garden Club. This contract represents the sole agreement between the parties, and no other representations, statements, or understandings are included as any part of this agreement.
10. **A vendor assumes all responsibility for the collection and lawful remittance of any and all sales tax required and absolves the CDA Garden Club and the garden owner of any liability.**
11. Vendor, including all owners, agents, employees or assigns of vendor, hereby releases and waives any and all claims for personal injury, product liability, theft, breakage, or other damage, against the Coeur d'Alene Garden Club, its agents, contractors, successors, garden owners, and assigns, from or otherwise pertaining to the space and equipment rental, and the Garden Club will not be responsible for any property losses resulting from theft, breakage, fire, water damage, or any other type of loss suffered by the vendor. Vendors are responsible for maintaining insurance on merchandise.
12. The Coeur d'Alene Garden Club expressly disclaims any obligation or representation related to the number of people attending the event or the potential revenue to be derived therefrom by vendor.
13. The Vendor agrees to follow the requests and directions of the Garden Club representatives onsite the day of the event.
