New requirement for United commercial

Beginning Feb. 1, 2025, United is adding the following GA modifier requirement for UnitedHealthcare commercial plans claims to their Charging members for non-covered services protocol. In addition to the consent requirements in the Protocol, if you know or have reason to suspect that a



commercial member's benefits do not cover the service (as described further in the Protocol), a GA modifier must be submitted on the claim if you want to bill the member for the non-covered service. See the posting here on the United
