BCBS postpones MAC claim edits, BILHPN Hosted Trainings, Incident To Billing, UniCare to Wellpoint, Yankee Alliance



BCBSMA is postponing monitored anesthesia care (MAC) claim edits

Effective for dates of service on or after January 1, 2024, Blue Cross Blue Shield was scheduled to implement diagnosis-driven claim edits to support monitored anesthesia care (MAC) medical

policy 154 guidelines. This effort has now been postponed, and any claims denied after January 1, 2024, will be retroactively approved, ensuring continuity of care for patients. BCBS will also notify providers 90 days in advance of any future enforcement of this policy.

As a reminder, medical policy 154 indicates that Blue Cross cover monitored anesthesia care for endoscopic procedures, such as colonoscopies and upper endoscopies, when medically necessary. Medical policy 154 also lists diagnosis codes and clinical scenarios where monitored anesthesia care is medically necessary for endoscopic procedures, outlined by certain medical conditions and complication risks.
