This was a jumper grab and pulled the player to the floor while White Team players was pulling off #4 he then grabbed player #11 then they both were having a jumper punch on until they hit the ground. I then blow my whistle and inducted to number #4 to follow me, and he was being reported for engaging in rough conducted. He then followed me off the ground to where I indicated to the bench he was reported and showed them my red card. He then walked off and knocked a chair over at the interchange bench then proceeds to walk to the changerooms. I then I ran back out to position to where my follow umpire had setup a free kick and 50 metre penalty for the White team. They then had a shot on goal and kicked the goal. | | | | | |
