DECEMBER 31, 1998

- **HML - DIARY ENTRY**: January 2, 1999 - "On Thursday, December 31st I picked up Adnan from his work + dropped him off at Sears so he could pick up his car."
- Thursday, December 31, 1999 – Work schedule of killer verified with employment records.
- Killer establishes WHERE he plans on murdering HML. - SEARS AUTO CENTER parking lot.
- Killer establishes HOW he plans to arrange to be in victim's car the day of the murder. – ASKS FOR A RIDE FROM HML THE DAY OF THE MURDER to take car to shop / or do something with his brother. ((Neither brother was with killer during the day.)) Eyewitness testimony overhears the killer ask her at school January 13th – day of murder.

ALTERED DIARY ENTRY ?

- Copy of Hae Min Lee's diary on the killer's wiki page run by Rabia Chaudry – date was changed to later in the year.
- June 28, 1998 - Adnan smoked marijuana. Baltimore Police Dept. page reference is in sequential order.
- FALSE date change to August 28, 1998. ([DIARY LINK](#)) <- compare to original BPDP files when received along with entirety of file for further discrepancies / missing information purposefully not uploaded.

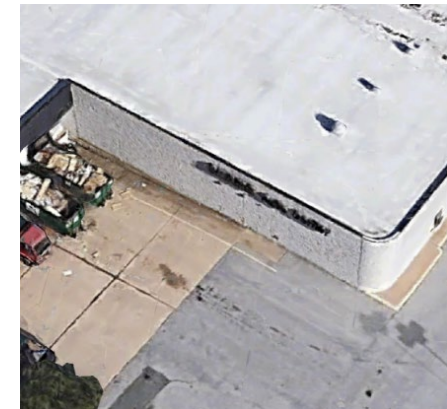
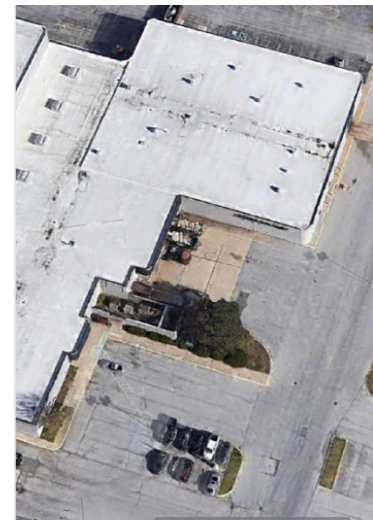

THE DRY RUN – DECEMBER 31, 1998

- Killer asks HML to pick him up from work and take him to his car at the Sears Auto Center.
- **Vehicle History Report for killers car was never serviced at the Sears Auto Center.**
- Killers' friend works at F & M Auto Repair ... If he was getting repairs done – why not take to his friends place of employment for servicing?

THE MURDER - JANUARY 13, 1999

- Eyewitness testimony from student at Woodlawn Highschool overhears the killer ask HML for a ride to get his car from the shop.
- **Vehicle History Report for killers car was never serviced at any auto shop OR Sears Auto Center.**
- Police interview with the killer via telephone - Officer Scott Adcock calls Syed asking if he knew where Lee was. The student told the official that "he was suppose[d] to get a ride home from the victim, but he got detained at school and felt that she just got tired of waiting and left," Adnan Syed.

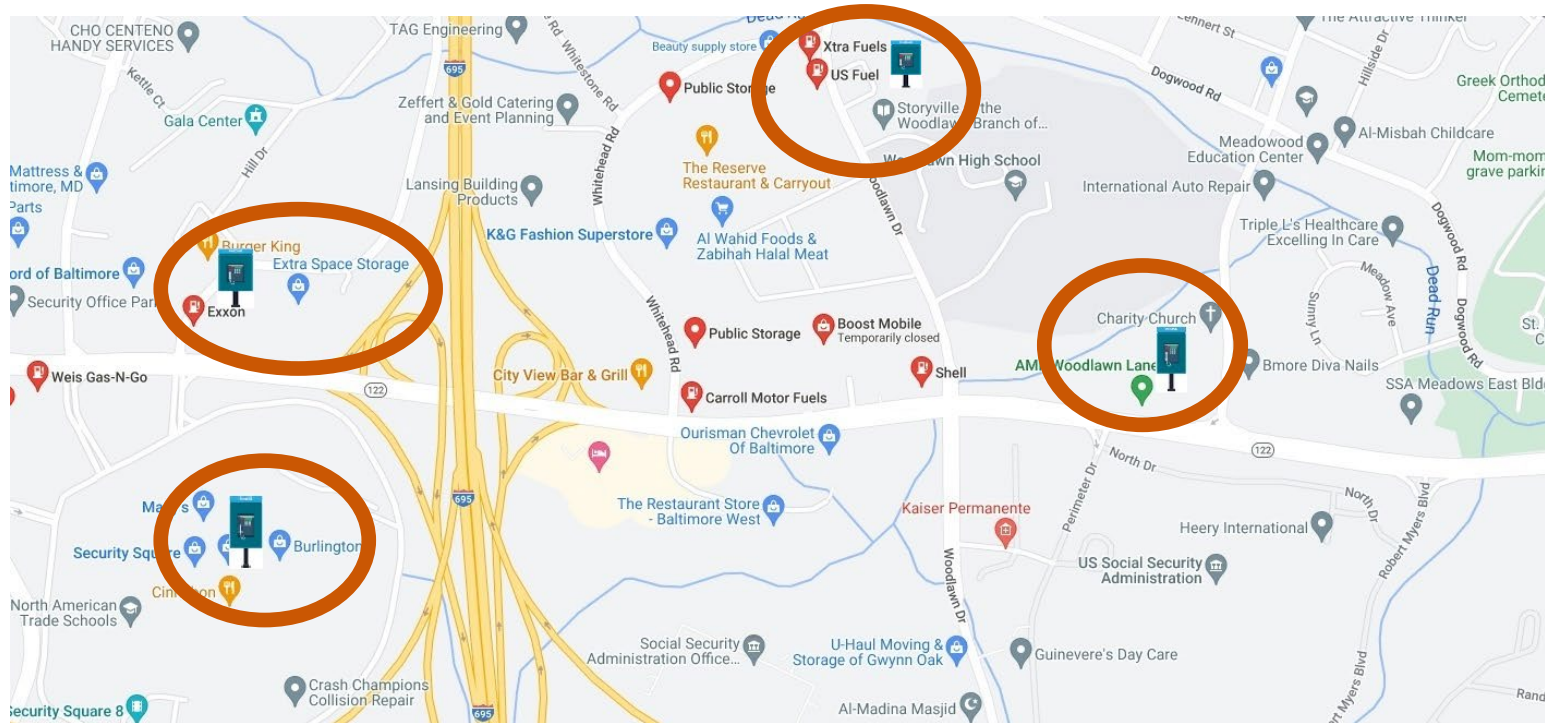
Vehicle History Report

- **Carfax** created the Vehicle History Report in 1986 available on ALL used cars & light trucks from the model year 1981 or later.
- **Carfax** data sources include every USA & Canada motor vehicle agency; collision repair facilities, auto auctions, police & fire departments and mechanics.
- A Vehicle History Report or VHR is a statement that will let you know information about the ownership and repair history about a specific vehicle from
- VHR reports are a collection of records that provide information about a used car that may affect your decision to buy or how much to pay for it. Records or events in the vehicle's life get collected from thousands of sources.
- The best-known vehicle history report services are AutoCheck and Carfax. These legitimate companies provide information that is collected from sources including insurance agencies, vehicle registries, and mechanics.
- Vehicle History Reports include- Vehicle Service History, Major Accident, Last Reported Mileage. Mileage Rollover, Airbag Deployment, Structural Damage, Multiple Owners, etc...
- VIN history accuracy ? Every car's crash and repair history is tracked by the *vehicle identification number* OR VIN. This 17-digit number acts like a blueprint of the car's track record.

Public Payphones

- **1995:** The number of public payphones peaks in America, reaching 2.6 million phones on the streets. ([ABCNews Article: History of Payphones](#))
- Public telephones, pay telephones, or payphones as they are more commonly referred to, reached their peak in the mid-1990s and early 2000s, when over 2,000,000 of them existed.
- In 1999, most gas stations, public schools, libraries and 7-elevens had payphones. *(see map of confirmed locations within walking distance of the killers location the day of the murder.)*

- **2001:** BellSouth was the first phone company to announce that it was getting out of the payphone business. ([ABCNews Article: History of Payphones](#))

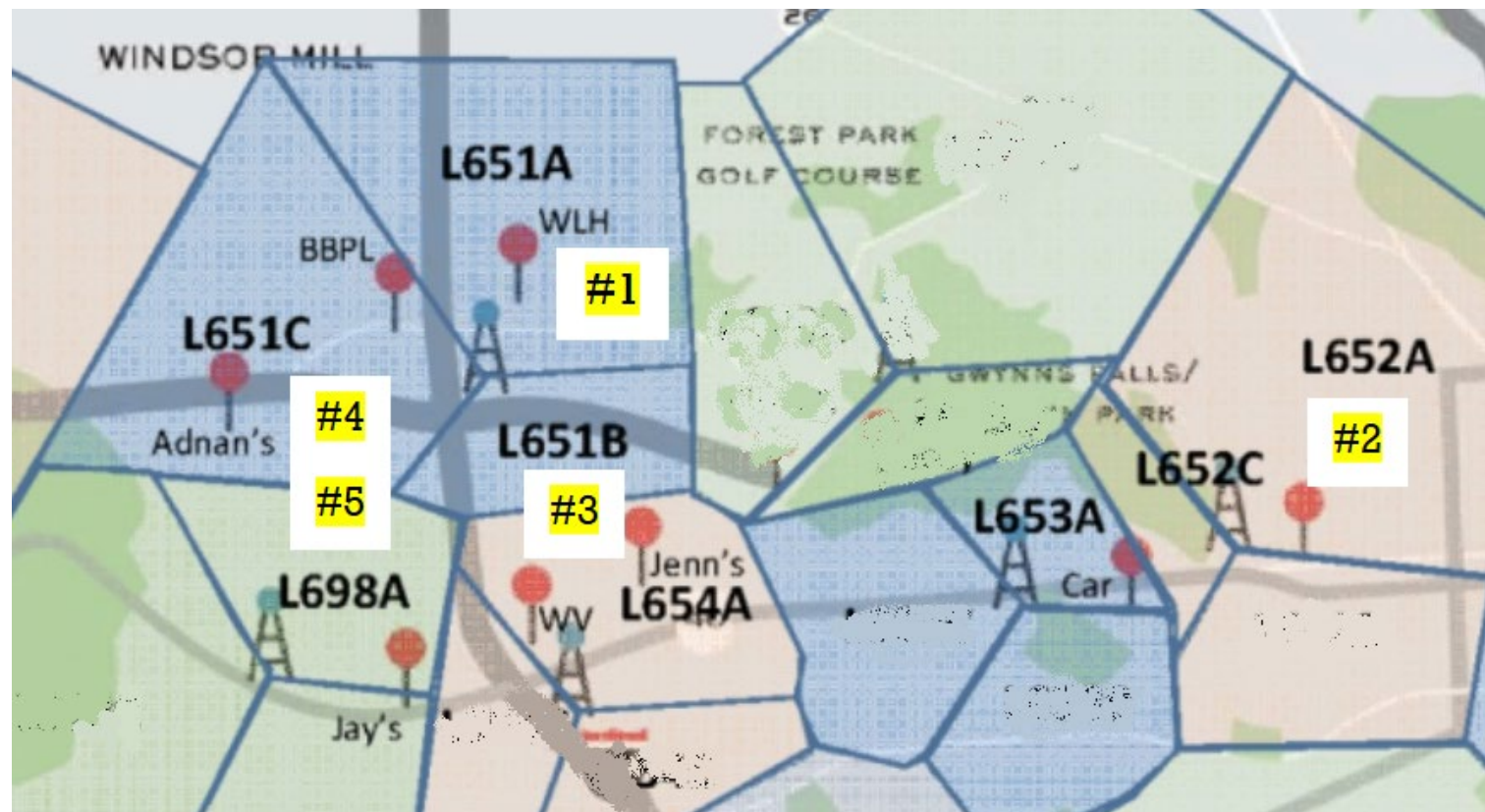

Re-enactment

- The killer methodically plans to murder Hae Min Lee over the course of the month from their break-up mid December to HML solidifying her new relationship with Don.
- He does a “dry run” on December 31, 1998. Once he has secured the location and the story to get Hae alone in her car – he has his friend from the Mosque purchase a cellular phone for him under an alias.
- The morning of the murder the plan goes into action. He leaves school and picks up his unwitting accomplice to go shopping and is dropped off at Woodlawn for his afternoon classes around 12:30pm. He calls a few minutes after being dropped off to make sure JW removes his cell phone from the glove compartment and makes sure he has it on and will answer it.
- At the end of school – the killer goes to the Woodlawn Public Library in the same property as the Woodlawn Highschool and is seen by an eyewitness who recalls having a conversation with him around 2:20 pm. (shortly after 2:15pm) This puts the killer and Hae Min Lee within 500 feet of each other the day of the murder.
- By 2:43pm – the killer is waiting for HML uses the payphone to call JW for a ride when Hae Min Lee pulls up having just left the refreshment vendor (apple juice & hot fries) & the gymnasium. She decides she has enough time to take AS to his car at Sears and if he drives she can eat / drink her snack & write the note she is planning to drop off to her new boy friends work with a rose she has for him.

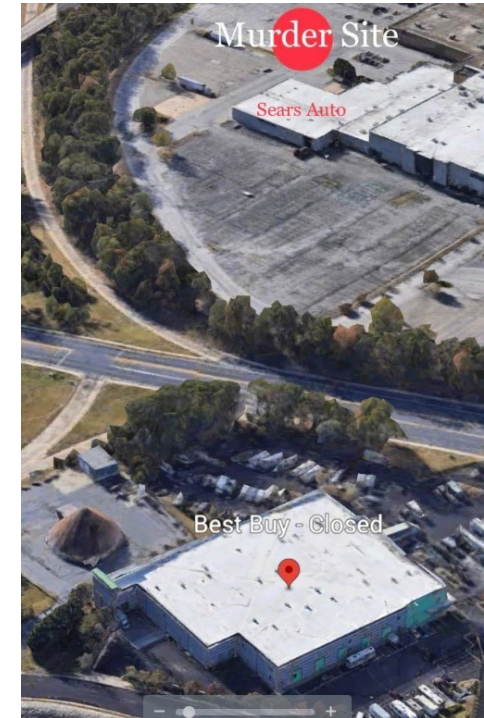
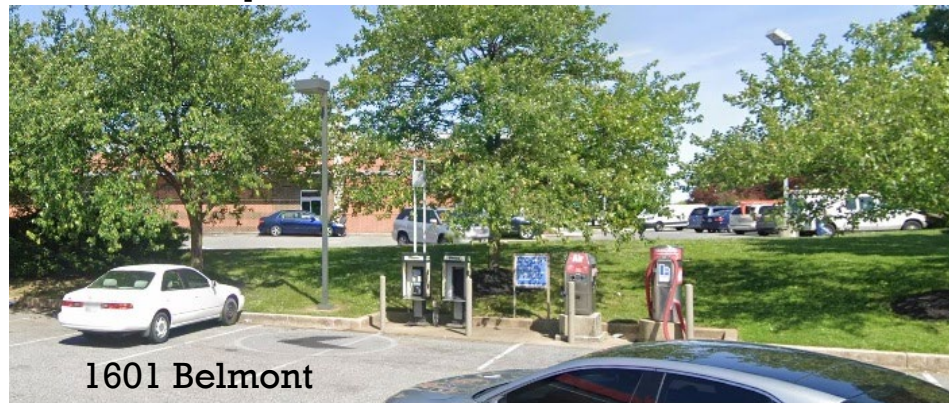

Re-enactment - continued

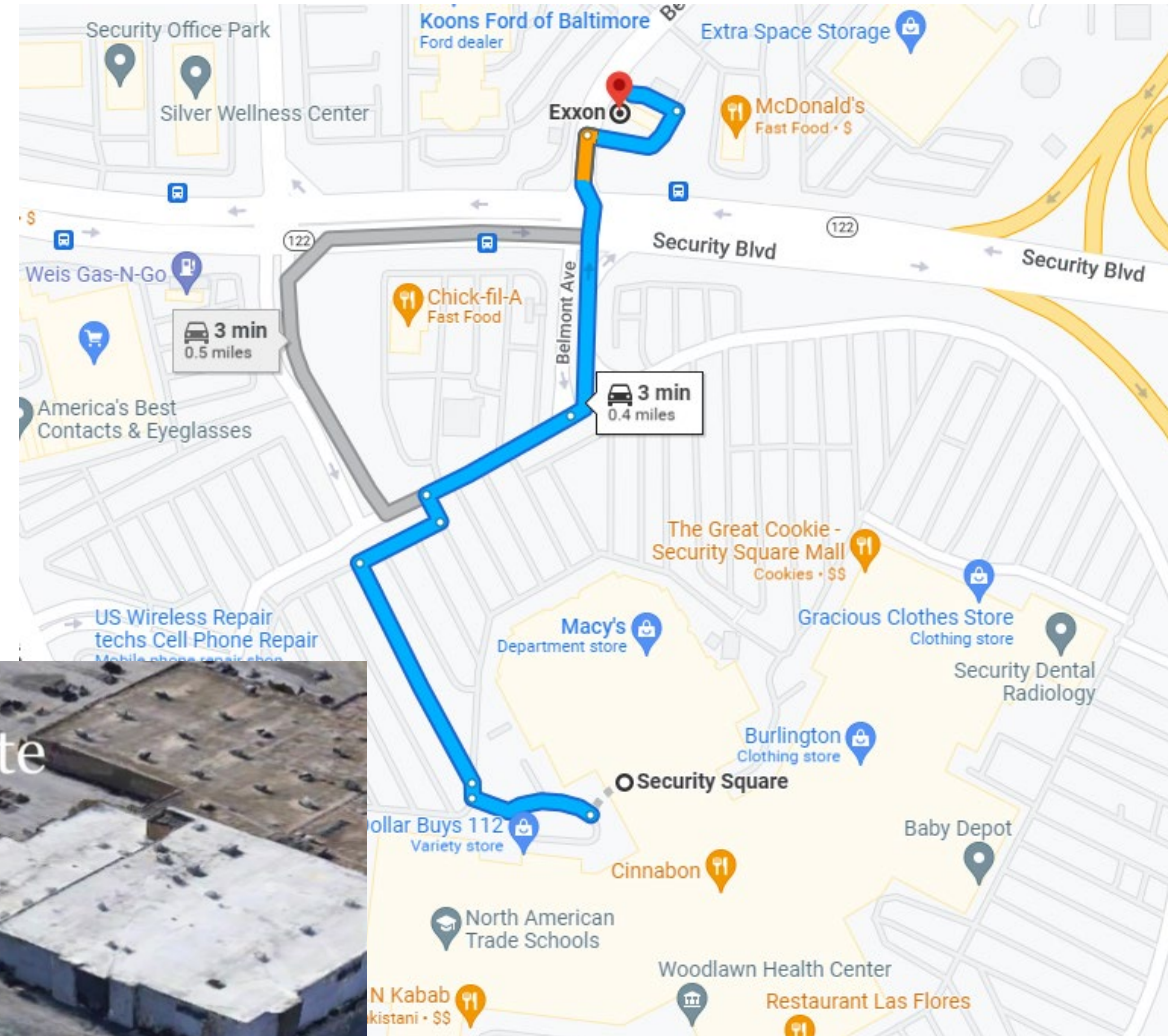
- During this drive – the killer is allowing his anger for HML breaking up with him to surface – as they pull up & park in the Sears Auto Center secluded parking area – he confronts HML about prom confirming she won't go with him but will be taking her new bf – which is just the push he needs to fly into a rage. He grabs the note and rose and throws them to the back seat and lunges for HML who is totally taken by surprise and caught off guard by the ferocity of his anger.
- She is struggling and fighting to fend him off – kicking ultimately breaking the windshield wiper switch in her car. After a 5 minute struggle - it is over. Hae Min Lee is dead. The time of death falls between 2:50 – 3:00 pm. Killer regains his composure over the next 10 – 12 minutes and moves HML body to the trunk.
- He then drives to the Exxon near the Best Buy and uses the payphone to call JW. The time now is 3:15pm.
- It takes JW approximately 8 minutes to drive from Jen Pusaterris house to the Exxon. Arriving at approximately 3:22 pm – he meets up with the killer and is shown HML's body in the trunk of her car. An argument ensues for a few minutes before they leave to drop off HML and the car at the Park & Ride off I70 and Security Blvd until they can dispose of the body later that evening after it was dark.
- They arrive at the Park & Ride and drop the car. The killer gets into his car with JW and telephones a girlfriend. The time is now 3:32 pm. Drive time from the Exxon to the Park & Ride is approximately 8 minutes. Arriving at the Park & Ride off I70 at 3:30pm.

Religious “good boy” – Fictitious Persona

- The killer stole large sums of money from the Mosque.
- The killer participated in underage gambling at casinos in Atlantic City.
- The killer smoked marijuana.
- The killer lied to his parents regarding his relationship with the victim.
- The killer could not recall the events that transpired on his Best Friends Birthday nor recalled that JW birthday was on the 12th – yet he recalls vividly a conversation between JW and himself at a school mates birthday party in early February.
- The killer murdered his ex-girlfriend.

Killers broken vows

**Do as I say not as I do. Faithful Muslim
– the Killer was not.**

1. It is considered a sin to have for an unmarried man and woman to have a sexual relationship or commit adultery.
2. To breach a promise that one has made.
3. Gambling money is considered immoral.
4. Being disloyal to parents, mistreating them or hurting their feelings.
5. Killing a human being
6. Theft.
7. Drinking alcohol.
8. Deception and evil schemes.
9. Cursing others.
10. Hurting one's neighbor.

EMT / EMS

- The killer was 17 years old and had worked for Rural Metro Corp for approximately 6 months during 1999 according to employment records.
- The killer WAS NOT certified as an EMT nor EMS. The killer was NOT certified to administer CPR.
- The State of Maryland requires applicants to take EMT / EMS certification courses / classes to be a minimum of 18 years old. Drug test are administered to applicants.
- FALSE NARRATIVE – during original trial.

What are the requirements to be an EMT in Maryland?

Initial Certification & Licensure Requirements

- Be at least 18 years of age. ...
- Successfully complete an approved EMS training course.
- Submit a Maryland Emergency Services Student Application form and fees (if required).
- Complete all additional requirements as listed for each EMS Clinician Level

Four Levels of EMS Certification

- Emergency Medical Responder (EMR).
- Emergency Medical Technician (EMT).
- Advanced Emergency Medical Technician (AEMT).
- Paramedic.

Windshield Wiper Switch

- HBO documentary: Confirm Rabia Chaudry received Producer credits which typically entails paying monies for the production costs.

Other Evidence

- Break up letter from HML to the killer – writing at the top of second page **“I’m going to kill”** in killers handwriting.
- MAP of area - torn with the location of Leakin Park where body was discovered - has killers PARTIAL PALM PRINT.
- Original afternoon timeline from the Park N Ride to the burying of Hae Min Lee – accurate multiple eye witness’ ; cell phone data and timeline presented by the Baltimore Police Department requires no changes.

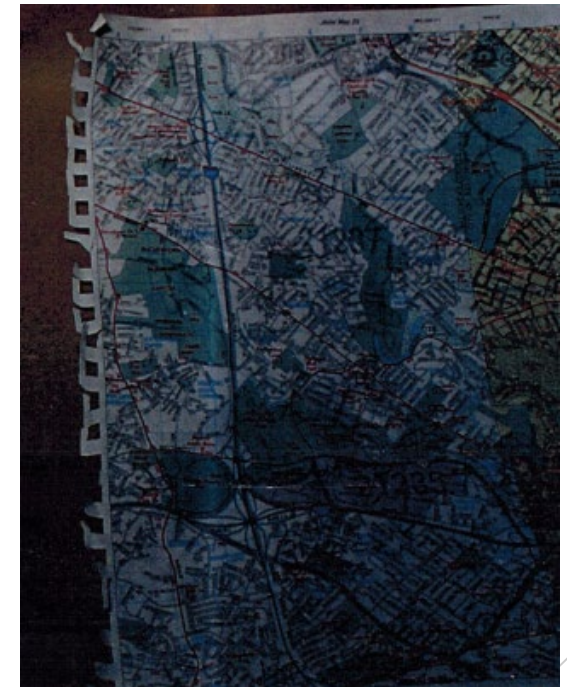

“Your Pathetic.”

- **TRIAL** – the day of Jay Wilds testimony the killer speaks to Mr. Wilds as he is taking the stand.
- **“*Your pathetic.*”** These are not the words of an innocent man being framed. Rather one who is angry that his unwitting accomplice confessed to his involvement and the details of the crime having felt remorse and guilt for his involvement.
- The judge admonishes the killer stating he has been good so far and not to blow it. ((paraphrased))

SERIAL Podcast / HBO Special

- Sarah Koenig, host – did they use the case files provided by Rabia Chaudry? OR did they request copies that were not altered OR left out on purpose to mislead.
- Holes – lead / scripted the show to be misleading and leaned towards killers innocence.
- Insinuates that former defense attorney, Guitierrez, mishandled killers case. See health issues and only complaint was overcharging by clients NOT misrepresentation nor poor handling of any cases.
- NOTE: I believe Gutierrez purposefully left out Aisha – as her testimony puts killer within less than an 1/8 of a mile on the same property as when HML was getting her snack and left the Gymnasium lot.
- HBO documentary: Confirm Rabia Chaudry received Producer credits which typically entails paying monies for the production costs.
- FALSEHOOD by Chaudry: Nissan advised her that the windshield wiper switch is simply screws in and could have easily come undone. FALSE – see images next slide. Extreme force is required to snap off the interior single unit switch so only the electrical wires holding it to the fuse is remaining.
- Killer maintains during 1999 police interviews he doesn't want his parents knowing about him dating the victim. FALSEHOOD – family knew about relationship. Mother ease dropped on their conversations frequently. Went to the dance and made a scene.

Marilyn Mosby

- Prosecuting Attorney in DA's office who advised judge "holes in case."

- Check for monies between Rabia Chaudry and Mosby – bribe for recommend?
- Check dates of indictment VS fast track release of killer.
- News and camera crew in court proceedings ... HBO documentary as well. Victims family NOT notified yet film crews knew of release / vacating of sentence.
- "Most recently, Berg was in the courthouse when Baltimore City Circuit Judge Melissa Phinn approved the motion to vacate Syed's murder conviction."
