AN AMENDMENT TO THE BYLAWS

This is an amendment to the original By-laws dated November 12, 1986 and recorded on February 10, 1987 in the Official Records Book 1404, page 938 et seq. in the public records of Polk County, Florida deleting the words "roofs and" from Par. b. Sec. 8 Article VI. Par. b. Sec. 8. Art. VI is amended to read as follows:

The Maintenance Committee, organized under a general chairman into two sections, Buildings, and Grounds. Each section may have its own sub-committee structure. The section on Buildings deals with the repair and replacement of ~~roofs and~~ walls and the appearance of carport and patio areas. The repair or replacement of roofs is the financial responsibility of the individual Villa owner. The GROUND S section will deal with lawn care, trees, shrubbery, roads and other common element areas.
