1. February 9th, 2010 Agenda

Because of increasingly snowy conditions, Charlie Smith suggested that the Agenda be amended to deal with New Business only. HCA Board members in attendance agreed unanimously.

2. New Business

Tom McConnell reported on the sinkhole that has formed in his front yard on Sourwood. He provided the board with a map and letters and emails on the subject. The problems that caused the sink hole dated back to 2007. VDOT filled in the sink hole that formed at that time with dirt rather than addressing the underlying problems. Carole McIvor and Charlie Smith led the discussion on methods to fix the current problem. VDOT has responded that the problem is not centered on the HCA easement. McConnell presented the damage resulting from the sink hole and the resulting flood in his remodeled basement. Trish Cuthbert asked for the estimates on the damage. Charlie Smith noted that HCA would fix the sink hole. As for the damages HCA's lawyer would be consulted on HCA's legal responsibility in the matter and an investigation would be carried out to find the origin of the flooding. Jeff Boutet also took part in the discussion. Jeff Boutet moved that HCA fix the sink hole and repair the damage to the yard, giving Charlie Smith the remit to assess the extent of the damage, obtain estimates and commission the work. Stephanie Johnson seconded the motion. It carried unanimously. The issue of compensation to the homeowner was deferred to the HCA lawyer.

Trish Cuthbert discussed the movement of funds into the CD.

Stephanie Johnson presented the pool management contract. Specific items of the contract were discussed. Stephanie Johnson noted that she was reviewing the new contract in light of the previous year's contract. Nancy Zingrone moved that Charlie Smith and Stephanie Johnson be given the remit to negotiate the final contract to closure on behalf of the HCA Board. Carol McIvor seconded. The motion carried unanimously.

The meeting was adjourned so that members could get home while the roads were still passable. All other agenda items were deferred to the March meeting.

6. Committee Reports

a. Pool Operations

Stephanie Johnson reported on damage to the pool cover and noted that she was looking for a new cover. Opening day for the pool was set for May 29th. A pool party was scheduled for June 12th. Pool chairs were being replaced; the pool drain was noted as still in progress and needing 20 more feet. New pool memberships were increased over the previous year. Anna Freshwater asked for clarification on pool membership policy and Carole McIvor asked for a clarification on ID cards for the 2010 season. Stephanie Johnson and Trish Cuthbert the system in place.

b. Neighborhood Liaison

Charlie Smith reviewed the Lake Hollymead bridge crossover and the trail work that was expected to be completed by May 19th. The trail will terminate on the Hollymead side of the lake and loop back on the Hollymead neighborhood trail. Forest Lakes will let HCA know when it is ready to connect the two trails.

c. Condomiunium Liaison

Ivo Romenesko reported that everything is fine with the condominiums and that nothing else needed to be reported.

d. Townhome Liaison

Anne Souder gave a brief report on the Somer Chase Townhomes.

e. Neighborhood Watch

f. Communications

g. Design Review

Charlie Smith reported on an approved shed project that has changed since approval to include a much bigger shed.

h. Landscaping & Grounds

Anna Freshwater reported that the drains had been finished as had the grading and mulch near the pool. Weeds on Sourwood needed leveling so that the area could be mowed. She also noted that the four bids had been received for the paving, ranging from \$18,575 to \$20,000 for 18015 square feet. SL Williamson's bid was accepted. A discussion ensued about when the best time would be to pave. Stephanie Johnson and Carole McIvor took part in the discussion. The issues included discussions over the smell, the best timing for the paving, the price and the impact on runoff. Carole McIvor moved to allocate \$1000 to build up the berm and spread more gravel plus \$1500 to repair and paint the parking lot fence. Anne Souder seconded. The motion carried unanimously.

Recreation No report was given.

<u>7. Old Business</u> No old business was raised.

8. New Business

Albermarle County Service Authority is replacing sidestreet water mains and putting in 6 inch mains all along the streets and to the existing fire hydrants. New hydrants are also being added to streets without hydrants. They are asking for 10-feet deep and 20-feet wide easements for the mains and hydrants. One of the easements coincides with the walk out from the Hollymead Trail (at the end of Goldentree). Stephanie Johnson moved to approve the easements requested by Albemarle County Service Authority. Carole McIvor seconded the motion. It carried unanimously.

7. 2011 Budget

Charlie contacted **Condominium Management** about managing Hollymead. \$2,000 monthly & 3% fee for additional subcontracting work. Will create 3% quarterly increase.

Changes with commercial property management: dues will go up, will need annual audit, \$1,700 to \$2,400, new owner packet income will go to mgmt. co., will have management company to call for association problems.

But lose other expenses: treasurer salary, office supplies, will keep basic website, drop payroll taxes.

Ivo said to ease into a contract, since once get away from citizen run organization, difficult to go back to self run. Carole McIvor will check out different property management company and get proposals.

Budget discussion put off till November 8, 2010 meeting to get input on cost estimates of property management companies.
