### Easy Lane Pond Work

There have been some major questions and concerns with the announcement of the work that the board of directors has contracted with WA Wells Excavating to do at the pond on Easy Lane. The pond, until last summer, had an overflow pipe that regulated the height of the water. The pipe broke off at the base (at bottom of pond). This project will lower water table to the designed level and earthen dam will be repaired and returned to a walking path as soon as the work is finished. The end result will be that the pond will be at the water level it was this time last year.

- 1. The high water level is encroaching on residents home and could potentially reach the house if we get more heavy rains. There is an emergency overflow built in, but it is slow to drain.
- 2. The earthen dam was not designed to hold that amount of water for an extended period of time.
- 3. The county has a sewer system running across damn and has expressed concern over height of water.
  - 4. Last fall a resident lost use of phone (the utility is too close to the water at this point).

# 2016 HOLLYMEAD POOL INFORMATION FOR HOLLYMEAD RESIDENTS

### **POOL MEMBERSHIP**

Homeowners or Renters residing in the Hollymead Community (which includes Hollymead, Hollymead Townhomes, and Somer Chase) are enthusiastically encouraged to join the Hollymead Pool. We have a new pool management company and expect that this will be our best year yet!

#### POOL SEASON

The pool will open on Friday, 27th May with our Opening Day party and will close on Labor Day (Sept 5).

# ONLINE REGISTRATION INSTRUCTIONS

Each household can purchase a pool membership for all members of their household. Relatives (adult children and grandchildren who do not reside with you) are not included in your membership. You may purchase guest passes for non-household guests as desired. Please DO NOT register anyone other than persons residing in your household. All members of your household will receive a pool pass (even young children). However, children under 12 (or those who have not completed the 5<sup>th</sup> grade) must be accompanied by an adult to use the pool. Registration instructions:

- 1- Log on to https://hca.poolepass.com.
- 2- Click "register here"
- 3- Enter registration information as prompted.
- 4- Check your email inbox or **SPAM** file. You will receive a verification email from the system. Click on the link in the email to return to the registration system and log in
- 5- Enter your address in the resident portion of the form.
- 6- Click "add resident" and enter information for each household member. The "image" field allows you to upload a photo. All photos should be .jpg or .png files, with a maximum size of 1MB). NOTE: the system allows you to enter medical information. This is not a required field, but intended to provide information for guards and EMTs in the event of an emergency.
- 7- Click "update data". This will bring you to the screen where you can repeat #6 and add all household members. THAT'S IT—You're registered!
- 8- You can manage your information online using the registration site (changes to emergency contact, medical information, photos).

Once registered, you will be prompted to send your payment to Horizon Community Services. Please make checks payable to Hollymead Citizens Association and mail to HCA-Pool Pass, PO Box 2070, Purcellville VA 20134. Send payment promptly: **Passes will only be mailed upon receipt of payment**.

If you do not have internet access to register for pool passes, please contact Horizon Community Services at 540-751-1888 and a paper application and rules acknowledgement will be mailed to you. You will also have the option of registering and purchasing pool passes at the pool once it opens.

Passes for 2016 are, like last year, keytags with barcodes on the back. When you go to the pool, each family member will have their pass scanned. Guards will ensure that only registered pool members gain admittance.

#### **GUEST FEES/GUEST PASS**

Each household joining the pool this year will receive 4 free guest passes with their membership. Registration through the online system is your agreement to abide by the rules. Please allow 5 business days for payments to be processed and keytags to be mailed. If you have your keytags from last year, they should work for you again this year (after you've paid your 2016 membership fee).
