SOUTH CONFERENCE WOMEN'S MISSIONARY SOCIETY AUGUST 8TH, 2020 CONFERENCE BRANCH MEETING VIA ZOOM/CONFERENCE CALL

Prior to the meeting being called to order there was an inspirational video played by Sis. Tamika Moore Allen. At 10:00 am the meeting opened with Sis. Altamease J. 1st question- What is the significance of plastic in our everyday lives? They are reusable.

2nd question- What are some greater alternatives to plastic? Insulated cups, a drinking glass, cloth bags and wire hangers instead of plastic hangers were some of the answers given.

3rd question- What are some of the benefits, if any? They are more sanitary, recyclable, saves money and convenient were answers given.

Sis. Melody Smith, of St. Stephens AMEC, Miami Gardens, Fl. Had a video played that enlightened us on how plastic harms the environment and they include the following: it's difficult to dispose of plastic, it harms wild life, and it is poisonous and a harmful pollutant.

Ways that plastic harms the economy include the following: it's bulky and expensive to package, difficult to brand, cost efficient for companies and a leading product in the economy.

Solutions involve greener alternatives, reducing plastic at a personal level, boil your own water and use glass containers. It was suggested that once the pandemic is over that the WMS members get together and participate in a Beach Clean up Day to help preserve our environment.

Dr. Clay thanked the presenters for an awesome presentation and for helping her fulfill her goal. She also stated that if any other YAMS at local churches wanted to do a PME lesson to call or email her and let her know.
