LIMITED POWER OF ATTORNEY

This Limited Power of Attorney (the AGREEMENT) is made effective on _____ (date) between: **STR8 Flow Logistics** hereinafter called DISPATCH a company established under the laws of the United States of America, and _____ Hereinafter called CARRIER, motor carrier company with MC# _____ And/or DOT# _____. CARRIER hereby appoints DISPATCH as my ATTORNEY-in-Fact (AGENT). DISPATCH's agents shall have full power and authority to act on my behalf. This power and authority shall authorize DISPATCH to manage and conduct affairs and to exercise all my legal rights and powers, including all rights and powers that I may acquire in the future. This Power of Attorney shall be construed broadly as General Power of Attorney. The listing of specific powers are not intended to limit or restrict the general powers granted in this Power of Attorney in any matter. DISPATCH shall not be liable for any loss that results from judgment of the error that was made in good faith. However, **STR8 Flow Logistics** shall be liable for willful misconduct or the failure to act in good faith, while acting under the authority of this Power of Attorney. I authorize to **STR8 Flow Logistics** indemnify and hold harmless any third party who accepts and acts under this document. This Power of Attorney shall become effective immediately and shall remain in full force and effect until revoked by me in writing.
