Responding submissions filed after this deadline or that exceed the page limits may not be considered by the adjudicator hearing the motion.

The party bringing the motion is invited to file reply submissions by April 25, 2024. Submissions shall be limited to 3 double-spaced pages, exclusive of evidence and authorities, and they shall be served on all other parties and filed with the Tribunal. Reply submissions filed after this deadline or that exceed the page limits may not be considered by the adjudicator hearing the motion.

If you do not participate in the case conference, the Tribunal may make a decision on the motion in your absence and without further notice to you.

The documents submitted by the parties for the motion may be made available to the public, unless the Tribunal orders otherwise.

If the parties reach an agreement on the motion prior to the scheduled motion hearing date, the party bringing the motion shall immediately advise the Tribunal in writing.
