WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**



(READ CAREFULLY – THIS IS A RELEASE)

I/WE HEREBY RELEASE, WAIVE COVENANT NOT TO SUE, AND DISCHARGE, the promoter, participants, rodeo association, sanctioning organization or subdivision thereof, arena operator, arena owner, officials, other participants, and persons in a restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers, and employees, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, my/our personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or any demand on account of injury to the participant, including death, whether caused by the negligence of the releasees or otherwise while the participant is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

The Restricted Area is defined as, but not limited to, the arena, chutes, staging areas, approaches thereto and all walkways, concessions, and other areas appurtenant to any such area where any activity related to the event shall take place, including the Deseret Peak Complex Indoor & Outdoor Arena and the Tooele Bit n' Spur Arena.

I/We will inform and instruct the said participant that upon entering any restricted area the participant must, and continuously thereafter, inspect such restricted area and all portions thereof which the participant enters and with which s/he comes in contact. I/We further warrant that the participant's entry to or upon such restricted area or areas and his/her participation, if any, in the event constitutes an acknowledgment that s/he (the participant) has inspected such restricted area and that s/he finds and accepts the same as being safe and reasonable suited for the purpose of his/her use, and if s/he feels anything is unsafe, s/he will immediately advise the officials of such and will leave the restricted areas. I/We understand the participant's presence at any event constitutes a model release for the use of any image, photograph, recording, etc.
