"Made a list of all persons we had harmed, and became willing to make amends to them all."

As we contemplate Step 8, let us look at where we are coming from. As we arrive at Step 8 having asked (prayer) our higher power twice (step 3 and step 7) for relief from "the bondage of self", what can we expect? We cannot overlook the grace we have been granted. Having, one day at a time, sobriety is not just the wearing off of the intoxication of alcohol. At this juncture we begin to feel the impact of our decisions on a spiritual level. We are NOT "faking it till we make it". Instead, we have made a commitment on multiple levels to take full responsibility in a way that will benefit others. This carries great weight within the fellowship as well as outside because now we venture out into the community.

He said:

There are many consequences of drunkenness. Some are permanent; some are not. Alcoholics Anonymous is open to anyone. But we must remember that there is no "free lunch". You have to pay to play. Even a broken clock is right twice a day, but one set to the wrong time is never right If our clock is reflecting faulty or even fallacious information, God is not to blame. Here the word clock means sobriety. As we crawl out of the quagmire of alcoholism, we can never lose sight of these stark facts. How can we ever hope to realize the 9th Step promises? For we are not just reading them off a scrap of paper. The "amazement" that is referred to on or about page 83, is a feeling that cannot be denied or postponed. It is akin to a fullmoon tide at flood. In my case, permeating my soul.

What will I do with this newfound "freedom"? I'm making my Step 8 list. Again, in my case I searched (cont. p 2) She said: Pride said "You need not pass this way," and Fear said "You Dare Not

Look." I've grown every time taking each Step, so no reason that now should be any different...So long, Fear. HELLO, COURAGE I appreciate that the Step Eight list begins with the WHO I had harmed - myself and others; and HOW my character defects adversely affected my relationships; then next the WHEN, WHERE and WILLINGNESS to begin the approaches. This practice allowed me to again detach from EGO while examining memories and seeing patterns in my attitudes and behaviors and relationships. I understand EGO as being Self-aware, maybe to include Selfcenteredness, Self-importance and Self-justification. I've looked at how my character defects have warped my "Self" spiritually, physically, emotionally, mentally (Steps 6 and 7). Now I get to look at how my special qualities affected others while I pursued that out-ofgrasp (fill in the blank) that I thought I needed to make me happy. MADE a LIST - Mom was first. One of my huge regrets was that I hadn't been receptive to her wisdom and love. With my other family members as well, I regretted not being Present when together, or avoiding them altogether. Coworkers - This was an early one as well. Some of the remarks I had made without thinking or putting myself in their shoes .. more cringe-worthy memories. I worked in an office and drank on the job. In wanting to appear capable and confident, I sometimes put on an arrogant (defensive) air. I might have even made (gasp) disparaging remarks about other coworkers. During college I lived with a young family with five kids. Several months I neglected to pay them the measly amount for my room and board. (see Step Nine) My Sponsor told me to not add my abusive former boyfriend to this amends list. AA

The Best of Big Book Dave:

August in Our History:

How did the world-wide custom of saying, "I am an alcoholic", at AA meetings begin?

Unfortunately, there are very few old-timers left and none of the have been able to provide plausible theories.

According to an early friend of AA, the late Henrietta Seiberling, this expression dates back to meetings of AA's forerunner, the Oxford Group, which had its heyday in the 1920's and 1930's. Henrietta had sought spiritual help in the Oxford Group when they first showed up in Akron. She is credited with introducing our founders Bill and Dr. Bob at her home on Mothers' Day, May 12th, 1935. All three of them were active Oxford Group members. At small Oxford Group meetings the members knew one another and didn't need to identify themselves. But, at large meetings, where there was 'witnessing', along the lines of an AA meeting today, personal identification became necessary so the alcoholics would know each other. "Chances are," Mrs. Seiberling said, "at some time one of the men stood up to share and after giving his name said, 'I am an Alcoholic' and the phrase just took off from there."

Early AA members do not remember that phrase being used at early AA Meetings as much as other words, at least in Akron, Cleveland area. Other words used to describe themselves were Drunks, Rum Hounds, or Boozers ... reminiscent of the temperance movements that gained adherents during prohibition and which most members of AA had lived through.

In New York, where Bill was from, the word 'Alcoholic' was rarely used before the publication of the Big Book. Some early east coast members said, according to their recollection, they first heard the expression as "I am an Alcoholic and my name is ...", and it came into being after World War II, 1945 or 1946.

It is a matter of record that in 1947 a documentary film entitled, "I am an Alcoholic" was produced by RKO Movie Company in Hollywood and from then on it began to be heard at most of our meetings.


