"Made a searching and fearless moral inventory of ourselves."

He said: And now comes the time when my locals hit the sand. Through my sponsor's suggestions I had to put pencil to paper. Being a retread, I never got this far. So now I have to write the great American novel.

I know I'm not Ernest Hemingway, but I have to write a moral inventory and be honest about it. What a dilemma.

As a child I was used to being behind a screen and telling a story about what I thought were sins. Now I'm faced with this moral inventory. How do I do it? My sponsor and the Big Book are very specific about the columns.

I started with column one. The names of people I thought had victimized me. Column number two, what was actually done to me? Now we're on the third column, my feelings and reactions to those events.

As I started writing, I noticed that the third column was full of one of three words, me, myself, and I, was looking at my behavior and how I had not only been the victim, but maybe the perpetrator. What a dilemma. For the first time in my life, I started to feel a sort of relief from those deep dark secrets that ate breakfast, luncheon, and dinner and I was paying the time. So, as I looked at this with honesty and trust, would I get the same relief that I noticed as these people who had sobriety? Could that be out there for me?

The book is very specific about this in chapter 6, Into Action, where it says, "if I don't do this, I will get drunk again". In past experience that's what happened to me. I got drunk again. Now finally this was a way to be relieved of the bondage of self. For me, on paper at the top of every page,

She said: I've seen many people freeze with fear at Step Four. The inventory of ur assets and defects is critical because it lets us see

our assets and defects is critical because it lets us see ourselves realistically and identify what blocks our connection to God. If I can identify what's hindering that connection, my chances of staying sober increase significantly. My sponsor had me list my assets first, helping me recognize the good traits in myself. As I continued with the four columns of Step Four, I detailed people, places, and things I resented. I also listed why, and which areas of my life were affected. The fourth column was a surprise because I had never considered that I might have a part in my resentments. Realizing I had stepped on others' toes, leading them to retaliate, helped me see my role in the situation.

The 12&12 discusses instincts and how they often exceed their proper function, leading to emotional problems. By doing Step Four, I uncover these emotional issues and bring them into the light, unblocking myself from God. When I'm not working the program, my instincts can go unchecked, resisting any self-reflection. Step Four is essential because it helps me take an honest inventory, address my defects, and prevent them from blocking my spiritual growth.

Step Four also reveals how my personality defects erode my security. Symptoms of emotional insecurity like worry, anger, self-pity, and depression emerge when I fail to recognize my inability to form true partnerships. The 12&12 emphasizes our inability to build genuine relationships, which is a key factor in our emotional instability. This insight made me take responsibility for how my defects had affected my relationships. It also

He Said (cont) I did ask the creator to help me be honest before I needed this relief not only for myself, but for those around me. Finally, the change was coming and the most notable progress was that my sobriety date didn't have to change. The change was within.

May the sunlight of the spirit be with you as it is with me.

She Said (cont) taught me to drop blame from my speech, helping me let go of the victim mentality and take responsibility for my actions.

I'm human, so I may still develop resentments. My sponsor taught me to go through Steps One through Five when facing a problem. I had a long-standing resentment against a former boss, and I needed to admit I was powerless over her. Then I came to believe that God would restore my sanity. The best choice was to turn my will and my life over to God's care. When I worked through the four columns on this person, I realized my part in the issue was expecting her to be different. Sharing this with my sponsor and seeking feedback was an important part of the process. I also learned to invite God into the room whenever I had to meet or speak with her.

Step Four is an action step, and each time I work through it, new opportunities for growth present themselves. I'm reminded of a quote from Melody Beattie's The Language of Letting Go (June 13), which says, "We can choose to live in the past, or we can choose to finish our old business from the past and open ourselves up to the beauty of today." This reminds me that I have the power to move forward and embrace the present.

The Best of Big Book Dave:

April in Our History:

April 2, 1840: The "Washingtonian Temperance Society" founded in Baltimore. 1000 Alcoholics the 1st year stopped drinking. Abraham Lincoln addressed their second anniversary. Within four years 500,00 had found sobriety. By 1850 completely disbanded! Bill W. made a textbook study of them and their mistakes as well as their strengths.

April 1912: Bill W. fell in love with Bertha Bamford, a classmate and the daughter of the local Episcopal minister in Manchester, Vermont where he was attending school. The fall of the same year Bertha went into the hospital for "routine surgery" and she died. This drove Bill into the second of three major depressions he will have in his life.

April 1939: Gabriel Heaters Radio broadcast, that was on seven nights a week, called "We the People" provided the first country wide exposure of AA to the public, by inviting AA members to be guests on the air.

April 1946: Our "Meeting in Print" was named "The Grapevine" but this title was challenged by the F.B.T. who also called their publication The Grapevine. This was settled by our magazines name being changed to "The AA Grapevine", and the April 1946 issue bearing this newly incorporated title was used for the first time.

April 1958: The word "honest" is dropped from our preamble ... The only requirement for membership is a (honest) desire to stop drinking.
