2. New Business:

- Website expenses
 - JoRina: Presents the information included in her website committee chair report attached as the last pages of these minutes.
 - Currently have 11 emails with GoDaddy. Discusses alias email and emails we currently pay for. Last panel created 4 emails, seemingly never used. Each email costs \$100.07 every two years, limited storage (5gb) per email.
 - Discusses suggestions about getting rid of certain emails. Intergroup involved also.
 - Jorina suggestion to get rid of 4 emails created last panel. Many ways to go with this, but would like direction from panel. Suggests the amount we're paying for emails is currently too much.
 - Using pre-paid/funded cards for expenses
 - Host gator: runs chair app, calendar, meetings. Received unexpected charges, Jorina negotiated charges and is receiving refunds. Sorting out who is getting the funds refunded and handling appropriately.
 - Scott asks if we've looked at other service providers, such as Gsuite. Can join committee to help.
 - Jim discusses that individuals are giving out personal contact information being represented as the AA "contact", suggests that we want to avoid this.
- Structure and Guidelines: Bob discusses nothing has been brought to his attention regarding changes or concerns, but he has some ideas.
 - Duties and qualifications of district officers. DCM be added to banking signature cards. DCM assists the secretary in making a monthly district meeting agenda.
 - JoRina: Qualifications of DCM: Her meeting liked everything other than sobriety requirements. Would like sobriety time more clearly defined. Discussion follows.


1 member celebrated 9 years of sobriety on June 15, 2025. We are having a potluck and cupcake night on Wednesday, June 25, 2025 to celebrate.

The Robert's Rules was first published in 1876 and were named for General Henry Martin Robert, a military engineer in the US Army. The rules spread to many countries governments including US and Britain. There are 15 editions of Robert's Rules updates 1876-2020..

The Short Form of the Rules the way AA uses them are:

- Raise hand. Speak after being recognized by Chair
- 2. Speak for two minuted only
- 3. No cross-talk-all goes through Chair
- a.To make a motion, "I move that". b."I second the motion" c.Discussion, d.Vote Yes or No
- 5. Minority opinion is given by a person voting against the motion (after recognition by chair). If someone who voted FOR the motion changes their mind, they raise a hand and Chair calls on them to announce the change. The Chair then calls for a vote (by Majority, 50+1). If majority achieved, group goes back to discussion of the issue (no other issues introduced). Then vote is again taken. IF the majority is not achieved to again discuss the issue, then the original vote stands

How do I create an alias?

You can create an email alias in the Email & Office Dashboard.

Can I create an alias with a different domain than my email address?

No, an alias must use the same domain name as your Professional Email address.

Example: If you have the email account jane@coolexample.com and want to create the alias contact@mycoolnewbusiness.com, it will not work. contact@ needs to be set up with the coolexample.com domain (contact@coolexample.com).

Will I see emails in my inbox addressed to my alias?

Yes. If you have the email account <code>jane@coolexample.com</code> and create the alias <code>support@coolexample.com</code>, mail sent to <code>support@will</code> show in your <code>jane@</code> inbox as sent to <code>support@</code>. This is true for both webmail and on an email client.

Can I send emails from my alias?

Yes, you can send emails from your alias in your Professional Email webmail. When composing a message, you can select the alias to show from. After selecting the alias to send from, your messages will show your alias address as the sender and disguise your primary

email address.



If you reply to an email that's sent to your alias, it'll automatically send from your alias.

Example: If you have jane@coolexample.comas your primary email account and you create the alias jobs@coolexample.com, all emails sent to jobs@goes into your jane@inbox. When you reply to mail sent to jobs@, it will automatically use your alias jobs@ so that the recipient never sees jane@.

What's the difference between an alias and a forwarding address?

When you create a forwarding email address, any messages sent to your Professional Email user is directed to a different email address. For example, if you forward email from sales@coolexample.comto jane123@gmail.com, all messages sent to sales@will automatically forward to jane123@. See forwarding options for your Professional Email address.

How long before an alias becomes active?

As soon as you add an alias, you can begin sending and receiving mail for it.

Can I turn an email address into an alias?

If a username is already in use, you will need to delete it before you can use it again. For example, if you have a mailbox for *joe@coolexample.com* and you want to create an alias for *joe@* instead, you would have to delete the *joe@* mailbox first.

What if my alias isn't working?

If your alias isn't working, try the following:

- Check that the alias is showing setup within the Email & Office Dashboard.
- · Check the alias' spelling. Typos happen to the best of us.
- · Confirm the sender is spelling the alias correctly.

Can an alias go to multiple email addresses?

You can't assign an alias to multiple email addresses.
