b) Reading of Tradition Four and checklist questions by Doug H.

Tradition Four: Each group should be autonomous except in matters affecting other groups or AA as a whole. 1. Do I insist that there are only a few right ways of doing things in AA?

2. Does my group always consider the welfare of the rest of AA? Of nearby groups? Of Loners in

Alaska? Of Internationalists miles from port? Of a group in Rome or El Salvador?

3. Do I put down other members' behavior when it is different from mine, or do I learn from it?

4. Do I always bear in mind that, to those outsiders who know I am in AA, I may to some extent represent our entire beloved Fellowship?

5. Am I willing to help a newcomer go to any lengths—his lengths, not mine—to stay sober?

6. Do I share my knowledge of AA tools with other members who may not have heard of them?

No Discussion.

c) Reading of the Concept III and questions by Bob F

Concept IV: At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in reasonable proportion to the responsibility that each must discharge.

• Do we understand the spiritual principles underlying the "Right of Participation"?

• What does "in reasonable proportion" mean? Do we understand when it is appropriate for A.A. paid staff to have a vote at the General Service Conference or in our local service structure?

• Do we expect that, because we are A.A. members, we should be allowed to vote at any group, even if we are not active members of that group?

Discussion followed: Mathea noted that the spiritual principles underlying the "Right of Participation" lies with those who participate. Those who do not participate have no right. Simple.

2. **Secretary's Reports:** Jeannie L, note taker for Shoshanah B, secretary. The Draft of the March 2024 District 6 minutes were distributed via email to the mail distribution list. Printed copies were available at the meeting. The minutes were reviewed.

Ann W entertained the **Motion** to accept the March 2024 minutes as presented / corrected; seconded by Mathea A.

Vote taken: All were in favor. No abstentions/ passed unanimously. Motion carried.

3. **Treasurer's Report:** Bob F- Bob distributed the March 2024 Treasurer's spreadsheet report via email and printed copies were also available at the meeting. See the spreadsheets for details.

Treasurer's Report for the Month of March 2024:

The District started the month with a bank balance of \$5789.82.

There were Group contributions of \$400.00 and a single expenditure of \$75 payable to the Lihue Lutheran Church for 1st Quarter Rent.

We ended the month with a balance of \$6114.82, a prudent reserve of \$1200 and an operating balance of \$4914.82.

We do have Outstanding payables to:

- GSB for \$3250
- Anastasia A for DCM Airfare of \$184.20
- Kauai Intergroup for Website and Virtual Meeting Expenses incurred by Aaron Lambert since the end of 2023 of \$400.80.

The Budget Committee has not been able to agree on a time mutually acceptable to discuss the 2024 Budget projections for the District.

Our 1st Quarter Contributions total \$1276.76 which is roughly \$300 or 19% less than last year.

Our expenses through the 1st Quarter are \$655.79, roughly 10% of the 2023 Budget.

The unfortunate part of the equation is that we are still not using those contributions in our direct community, here on Kauai. Primarily due to a shortage in people-power.

Ann W. entertained the **Motion** to accept the Treasurer's report as presented/corrected and was seconded by Mathea A.

Vote taken: All were in favor. No abstentions/ passed unanimously. Motion carried.

4. Alt DCM Report: Jim D:


- Waimea Canyon Group Shoshanah B reporting: meetings are going well and seeing increased numbers with newcomers and strong support.

10. New Business:

Jim D, spokesperson for Happy Hour, reported about their proposal to add a paragraph to the *Living Sober* book (chapter 29). District passed it. District took it to Area 17. The first vote did not get the ³/₃ majority. One member spoke to the minority about how that paragraph was necessary. Another member agreed. Another vote was taken and the vote was changed. It passed the area 87 to 14. Somehow, the proposal didn't go to the Conference. In follow up, Jim D went to the Forum on Hawaii Island and asked at the Mic why his home group didn't get a letter of decision from the GSC. Steve Q, DCM DIstrict 6, called GSO/Conference Coordinator and it finally went to the Literature committee. The conference conclusion was that it would best be placed in a new pamphlet about the Three Legacies currently under development that it would best be placed in a new pamphlet about the Three Legacies currently under development. The proposal places Tradition 5 "our primary purpose" foremost and needs to be revisited in the future.

Anastasia commented that specific wording should be emphasized in a proposal and reminded us that change takes time—years perhaps.

Doug said that he has a personal connection to the KCCC system, separate from our AA pathway. The general agreement was that we need to go within the current AA correction system which is Corrections Chair, Garrett S, and Kalei K, KCCC contact. Mathea A referred the District members to the AA Corrections Guidelines from Area 17 and the General Service Office as well as District 6 Structure & Guidelines.
