<u>East Side Wahine</u>: Carolyn V. reported that this Kapa'a Closed Women's Group, which meets every Thursday at 7:00pm, at the Kapa'a United Church. The meeting's attendance is excellent, at 12-16 people. We currently don't have a GSR.
