

"Humbly asked Him to remove our shortcomings."

**He said:** The Seventh Step Prayer: "My Creator, I am now willing that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows. Grant me strength, as I go out from here, to do your bidding. Amen"

The first sentence of this prayer is the foundation upon which I will continue to build a relationship with God as I understand Him. It takes into account the true nature of my humanity and makes me aware that every facet of my personality will need to be given over to this Power, not just the ones I think are troublesome to me personally. It is an invitation for God to come into my life on a daily basis.

The second sentence is my acknowledgement that I have defects of character which only He can remove. He does not need my help to point out which ones I want Him to take away. They will become abundantly clearer to me as time goes on. I will continue to stumble and trip over the same ones time after time until I have that "Ah ha moment". My God will sometimes allow me to keep some of my "good character" to show others the foolishness with which I can delude myself about my spiritual growth. Other times I will choose to hold onto them until they make me so uncomfortable that the only way to get relief is to drop them as if they were burning hot coals. I do not know which of my defects stands in the way of my usefulness to God and my fellows. God makes that distinction. I am either a student or a teacher, good or bad as the case may be but I am not always aware of which one I am in the moment.

The third sentence is where I am asking for the (Cont. p. 2)

She said: The word "humbly" needs to be looked at in this step because it is imperative. My understanding of the word is that I know who I am and my right place in life. I am no longer low of the low nor am I better than everyone else, It's putting myself into true perspective. I believe it's a necessary part of the step because without humility, I cannot ask for help and that is exactly what is happening. I am asking God (or whichever word you choose to call your higher power) to do something for me for which I cannot do on my own. How do I know this will work? Because of my previous experiences with the other 6 steps. God has ALWAYS been doing for me what I couldn't do for myself!

However, "removal" didn't happen like a flash of lightening, striking me white as snow. Oh no! God didn't just swoop down and take away my characters defects. How simple that would have been. My experience is that He provided me with plenty of opportunities to learn how to choose differently. For example, one of my flaws that needed removing was impatience. God didn't just render me patient. Nope. Many situations were created for me to LEARN patience. First of all, the situations helped me see that there was something that needed to change. Then they gave me plenty of chances to practice patience, over and over in some cases where I may have been a little slow in the learning curve. Thank goodness this program is about progress and not perfection.

**Page 76 of the Big Book**, has a wonderful prayer that can help one foster the willingness to work Step 7 and humbly ask God for removal of our defects. If those words work for you great. If not, make something up!

I must believe that I am capable of changing for the better and becoming a healthier human being and that God is there every step of the way, not only when life seems so messed up but more importantly when all is well. I must give Him all the credit for my Sobriety, but my recovery is my responsibility. I must do the work.

She Said (cont.) We are creative beings who can think
for ourselves. Do not use the wording as an excuse to
not move forward in life. Our ego/disease wants to trip
us up getting hung up on words, prayers or semantics.
It's just trickery to keep us sick. After the prayer is said,
a letting go MUST occur. We must have an allowance
for God to remove the defects. If there is still
resistance and clutching to something we think still
works for us in some twisted way, go back to Step 6
and once again become entirely ready. If something is
really too scary to let go of, perhaps seek help from
your sponsor or another trusted member of AA who
has worked the steps. Find out their experience,
strength and hope. That is why we are here, to be a
guiding light for those newer on the path.

#### The Best of Big Book Dave:

#### The Month of July in Our History:

July 15<sup>th</sup>, 1938: The first documented use of the A.A. name in our General Service Office Archives. It is in a letter from Bill W. to Willard Richardson (nonalcoholic trustee). Bill started using the name "Alcoholics Anonymous" both as the working title for our book and then as the name for our membership.

**July 1936:** At Lois and Bill W's home on Clinton St., Brooklyn, a group of hard-core alcoholics was developing weekly meetings while Bill was receiving strong criticism from the Oxford Group.

**July 1942: Opening in New York City,** Riverside Hospital, which has the first alcohol treatment facilities for adolescents in the U.S.

**July 1949: The first medical journal** about A.A. is written by Dr. Silkworth.

**July 2, 1955: "The Saturday Evening Post"** magazine has a long article written by Jerome Ellison. It is about help for the families of alcoholics through Al-Anon. As of 1955, the article says, there are 700 Al-Anon groups nation-wide.

**July 1965:** At our International Convention held in Toronto, Canada, Bill led thousands of A.A. members in our "I am responsible" pledge for the first time! It was written by AI S.

**July 1967: The American Medical Association** passes a resolution identifying alcoholism as "A complex disease and disease that merits the serious concern of all members of the health professions."
