

"Made a decision to turn our will and our lives over to the care of God as we understood Him."

He said: when I finally made it to AA and was introduced to the Big Book and the Steps, I was instructed to read through from the beginning and to stop at the end of the paragraph that begins - *Being convinced*. I did what I was told and was able to concede on a lot of the points made in the previous chapters, but still was a little shaky on the God idea.

I believed I would have to begin living like some of those "church-going folks" in order to live a godly life. I was sure that it would not be possible for me to accomplish this, nor did I want to.

**Early in my** sobriety I had the opportunity to go to a meeting somewhere in LA that had a copy of the original manuscript from chapter 5, *How It Works*, in a glass frame. I read it and what stuck with me was that instead of saying rarely, it said never, and then it said "having read this far if you are not convinced, reread the book or throw it away."

That is one heck of a statement. It made me seriously reconsider the prospect of getting busy with the steps, honestly and vigorously. The 12x12 states that the effectiveness of the whole program rests on how well and earnestly this step is performed. Why is that?? When I was in charge of my life and doing as I pleased, whenever I pleased, there was a lot of chaos, confusion and destruction. I was aware of the mess I was making and deluded myself with empty promises of making it better as soon as all my ducks were in a row. The only problem with that was those darned ducks keep running all over the place; it was hard to keep track of them.

**Only when I** came to the realization, with the aid of a sponsor, that maybe I should be held accountable to someone or something else and take responsibility

She said: In short: "Thy will be done". That meant getting out of the way; to stop trying to play the director in my life and everyone else's lives around me. Forcing my will is an act of selfish and self-centered fear- based action that never turned out well for me, ever.

I truly did not understand, when I first crawled into AA, what the Big Book spoke about on pg 62, where it states "So our troubles, we think, are basically of our own making". WHAT? Why in the world would I put myself into all of the messes that I found myself in?!? I have learned it's not because I set out with the intention of screwing up my life. I did it with the actions that were born out of fear and self will. When I became willing to be honest, "I" was the common denominator in ALL my affairs. Ironically alcohol was not. I was.

Now that I have this new found knowledge, that I created this mess, what can I do about it? I can become willing to make a decision to let God be the one to run my show. There were a myriad of emotions running through my mind. First, I was actually relieved to know that I don't have to figure this out all on my own. I also wanted to cling to the illusion of control. Though it had never worked for me in the past, my ego was afraid to let go. I felt comforted that I could turn my will over to my higher power, but my life? My whole life? Seriously, everything in my life? YES! For my higher power permeates my entire life, every aspect, every nook and cranny. Finally, there was willingness to try something different. I saw demonstrations of changed lives because of this NEW way of living. A different way to live? Wasn't that what I was here for? YES! I also kept hearing over and over... "If you (Cont. p. 2)

Willingness to take this step has proven to be the keystone of the new and triumphant arch through which I passed to freedom. That is the keyword. Today I am free from the bondage of my alcoholic mind, one day at a time, as long as I trust that God has the best possible plan for the new life he has graced me with.



#### **Interesting Dates in AA History in March**

**March 2015: Thanks to Irene R. the Anchorage Archives** Committee has received a copy of a speech Bill W. gave on July 24<sup>th,</sup> 1969 before the US Senate. It is eleven pages long and the subject is, "The Impact of Alcoholism." It's members like Irene that keep the history of A.A. in the forefront of our movement. Without the knowledge of our past we have no tomorrow.

March 1941: Cleveland, Ohio forms the first Women's AA Group. The Secretary for this group was Marion R. and could be written to at 12214 Detroit Ave., Cleveland.

**March 5th, 1945:** Radio station W.W.J. in Detroit, Michigan, pioneered a weekly program put on entirely by AA members talking about AA. They also took phone calls.

**March 1948:** Richmond Walker finished the "24 Hour A Day" book, printed and distributed on his own.

**March 1954:** Marty M. (story in the Big Book) was providing so much factual education to communities nationwide about alcoholism that she was named 'One of the Ten Greatest Living Americans.'

**March 21<sup>st</sup>, 1966:** Passing away on this date Ebby T., the one and only sponsor of Bill W. Ebby brought Bill the message of sobriety, Big Book pages 9-10-11-12.
