#### "Admitted to God, to ourselves and to another human, being the exact nature of our wrongs."



He said: Hello my name is Jeffrey and I am an alcoholic. My sobriety date is June 5th 2018.

This is my experience with Step 5.

First, I want to let you know it is not my first Fifth Step. I have done many before, but all of them were half measured. The results of half measuring will get you drunk. I heard in a meeting one time if you don't do an honest 4th Step you will end up drinking a fifth. I couldn't agree more because for years I had no God and I was unable to do an honest Fourth Step, which made it impossible to do a Fifth Step the right way.

In this sobriety, because I work the steps like my life depends on it, I left nothing out of my Fifth Step. My sponsor's directions were to read and highlight page 72 to the bottom of 75, stopping at returning home, and praying for honesty, transparency and clarity. When I was finished with that I was to call my sponsor and set up an appointment. I met with my sponsor and for the first time after 18 years of failed sobriety's, going in and out of this room. I finally turned everything over to God and my sponsor and let it all out. The experience I had with this process was life changing.

My 5th Step took just a little bit over 9 hours, and when I left his house I felt the weight of the world was finally lifted off my shoulders. This is because I held on to nothing. In the past I held onto a lot of things and tried to shove them down. Eventually it would be too much and I would drink again. This time that wasn't the case. When I was driving home from his house I had to pull my truck over because, as I said, I felt the weight of the world was finally lifted off my shoulders. I thought I was floating out of my driver's seat and I had to check my seat belt! When I got home I was to do an hour of meditating, praying and going over my 5th Step, to make sure I' left nothing out. This was the first time I had (Cont. p. 2)

**She said:** when I came into the rooms of Alcoholics Anonymous and saw this Step printed on a scroll hanging on the wall, I thought to myself "no way". I was so ashamed of myself and the person I had become I was certain I would take my secrets to the grave. The biggest fear I had was exposing the skeletons in my closet to someone and have them shame me further or share them with everyone in the program. I had very little trust in other people and my higher power. I just couldn't see how telling all would help me. Now I know why admitting my defects to another person and not just to myself and

my higher power is so crucial.

After finally finding someone I was almost certain I could trust and we started the 5th step process I was amazed before I was halfway through. My sponsor was so kind and non judgmental that I began to feel at ease almost immediately. It was the first time in my life that I felt safe and relieved to tell the truth. I also learned that part of the purpose of the Fifth Step was to improve on the truth as I had seen it from my perspective. What is still true for me today is that when I'm in the middle of an emotional disturbance I can almost guarantee that my perspective is skewed by the "ism". "What comes to us alone may be garbled by our own rationalization and wishful thinking". 12 & 12 p. 60. In some areas I needed help with understanding the exact nature of my wrongs. In some cases I took too much responsibility for situations and beat myself up mercilessly for what happened. In other cases my ego did not want me to admit I harmed someone. Being an outside observer, she helped me sift through the confusion so I could get a clear understanding of the situation.

As we trudged along the 5th Step process I began to witness another very new and completely foreign

I thank God every day for my sobriety. Every single day I kind of laugh at myself because doing this work really isn't that hard, but our minds will tell us it is. By doing an honest 4th and 5th Step, and starting that process of cleaning house, my personal house, my life has been better and better every day.

If you are in the middle of your Fourth Step, or doing your Fifth Step, the one recommendation I have for you is do not edit. Hold on to nothing. Let it all go to your sponsor and God and I guarantee you your life will get better. There is nothing too sick, crazy or disastrous that you have done that somebody else has not also done. Let go and let God help you through this process. ~Jeffrey P.

**She Said** (cont) concept, humility. I began to feel like I was no longer the worst person on the planet. My sponsor freely shared similar experiences she had while drinking and this simple loving act helped me to end the isolation I had with my fellows. She reminded me that I was a child of a loving creator and while I had made mistakes, I was not a mistake. I was no better and no worse than anyone and that we are all equals, and I was on a spiritual path, making an effort to end the vicious cycle of alcoholism and make amends. I also got to see that those who had harmed me were very similar to me; wounded, spiritually sick people that were doing the best they could with what they had. Forgiving these people gave me more freedom than I ever thought possible. The 5th step strengthened the fragile beliefs I had about myself, other people, the program and a higher power. It made me want honesty, unity and humility more than I wanted isolation, fear, and deception. For me the 5th Step was a turning point. I went from desperately fearing the changes I had to make to wanting a higher power to ~ Janice M., Kauai change me.

# The Best of Big Book Dave: May in Our History:

May 1939: In A.A.'s beginning the first "Intergroup" was called the "Central Committee" in Cleveland, Ohio. This was 4 years after our cofounders first met; a committee of 7, including Dr. Bob was meeting once a month to 'coordinate' efforts regarding sponsorship and hospitalizations. Dr. Bob was not only a supporter, but an active participant of this committee.

May 1943: The second Intergroup office opens in Columbus, Ohio. In May 1944 Los Angeles opens their office. A.A. was not easy to find but selected groups of priests, ministers and judges in the early days had the Intergroup's phone numbers. These numbers were not listed anywhere else!

Before the first General Service Conference was held in New York, April 1951, 16 Intergroups were serving local groups. Today there are over 1800 of these offices in North America!

May 20th, 1908: The Birth date of Sybil Maxwell; Born: Sybil Doris Adams in Simmons, Texas. She will become the first woman west of the Mississippi to sober up in A.A. and stay sober.

May 1932: Rowland H. visits with Dr. Carl Jung in Zurich, Switzerland for one year to 'cure' his alcoholism. Dr. Jung finally told Rowland there was no medical or psychological hope for an alcoholic of his type, except perhaps a spiritual conversion.

Rowland returned to the U.S. and joins 'The Oxford Group.' This is considered by most historians as the first link in a chain of events that led to the founding of Alcoholics Anonymous.

**May 12th, 1935:** Bill W. goes to Akron, Ohio on a business trip that fails, where he will meet Dr. Bob for the first time. Because of this meeting most archivists believe that the birth of A.A. took place one month later.


