- Are we willing to do what it takes to insure that our democracy of world service will work under all conditions?

Tradition One:

Our common welfare should come first; personal recovery depends upon AA unity.

Long Form:

Each member of Alcoholics Anonymous is but a small part of a great whole. AA must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows closely afterward.

Secretary Report: Minutes from December minutes were provided to group via e-mail. **NOTE: District 6 needs a Recording Secretary.** Ann W. took minutes for this meeting.

Treasurer's Report: Steve Q provided a Treasurer's report; report accepted. Steve also reported that there are 53 total paid registrations for the upcoming Area Assembly. Steve is working on the proposed budget and thank you letters for contributions.

Alternate DCM Report: Please provide Ann (781-405-4655) with your Group information – contact info, GSRs, Group numbers etc., so she can update District 6, Area17, GSO records.

Focus of activity this past month has been on homestays for Assembly. Also working on updating the Kauai group list.

Intergroup Report: Mathea reported for Intergroup.

The Nooner's listing in the meeting schedule is incorrect; the correct schedule is M-W-F at 12N, the Men's meeting is Monday at 6 PM and the Women's meeting is Wednesday at 5 PM.

Jim DuB. Raised an objection to the District meeting regarding two groups collaborating to send a member of one group to PRASSA. He reports that Happy Hour was going to send Crystal to PRASSA and that this will not represent the group conscience of Hui Ohana. Jim voiced the concern that this is not consistent with Tradition Two. A discussion followed. Brian from Happy Hour reported that this had been discussed and voted on at a business meeting at Happy Hour and that the group was supportive of this decision. Susan Ok reported that groups have collaboratively supported one another in the past here on Kauai, i.e. Sunday Serenity shared GSR and expenses with Steps to Freedom.

DCM Report: DCM Jonathan asked that the attendees keep asking for homestay volunteers and help with food. He also asked attendees to announce at meetings that District needs a secretary.
