One discussion for the Groups would be regarding what events to include. For now the site reads: Information on events and links to flyers do not imply endorsement - see disclaimer below. Sober events may be listed if they are for enjoyment by members, and family and friends might participate as well.

The <u>draft disclaimer</u> is also included for your Groups' perusal. Most of the wording was adapted from <u>Area17's website policy</u>, which can be read here: http://www.area17aa.org/area17/wp-content/uploads/2009/11/200910_web_guidelines.pdf What may be of interest is the issue of autonomy, where each <u>Group</u> can decide for itself what information they do or do not want on the website if they are approving or sponsoring an event; see item 1.3 on Area's page:

1.3. Autonomy will be respected. Each district or standing committee will decide for themselves what information they do or do not want on the website, provided such contents falls within our policy, as well as the extent of their participation in the area website (Tradition 4).
