Saturday we began the assembly with an overview of the process and preparation of the General Service Conference, to be held in May 2019. Our purpose of this assembly was to discuss, consider, and then inform our Delegate, Colleen, as best informed as possible, to what each committee / panel suggests it do on the proposed agenda items.

Representing District 6 as the Alternate DCM, I was on the Finance Committee, panel 12. Prior to the assembly, I reviewed the background information and Janice provided me with her input on the topics at hand.

The first topic for review was the self-support packets that go out to the DCM's (item IV, the DCM provides this to the district treasurer). The committee agreed that all of the items in the current self-support packet to be kept as is, and to ensure all items are up-to-date. Janice suggested the "idea starter" document (ref: F-19E 4/96 1M) be added to the packet, the committee concurred and our delegate thought it was a great idea.

Secondly, we discussed policy and admissions (item VII) regarding the process of approving representatives from other AA service structures (other countries) to observe the US and Canada conference. This is so that these representatives can set-up a similar GSO structure in areas where none exist. This is really more of a formality of approval. All persons that wait to get into the General Service Conference who are members of AA, are always approved. There was some discussion about other parties such as NA or AI-Anon being allowed into the conference, however this was a non-issue since the conference does not allow members outside of an AA related representative to be let into the conference.

Our district had a few questions regarding this topic, to include:

1. How many requests to observe are approved/denied? **All are approved**
2. Is everyone approved? Is the approval process a formality? **Yes (all AA), Yes**
3. Can it be done ahead of time? **No**
4. Can the committee that decides the day before the conference receive the information earlier? **Perhaps. Colleen will take this into consideration for the GSC.**

The third topic discussed was item IX regarding report and charter – which refers to the continued publishing of AA directories. Some of the highlights included that online printing is not inclusive, and how rural areas get connected. No recommendations were needed here, it was only up for discussion and consideration.

Our district wanted more information, and we proposed this to our delegate since it was not available: how many directories are sold, how much it costs to maintain printing, and who is buying it.

Later in the assembly our group presented our discussion and considerations to the group and our delegate.

The following are highlights from all of the panels and what the committees recommended Colleen take to the GSC. The topics were covered over the course of Saturday and into Sunday, all of which I partook in discussion and voted on:

#### **Panel 1 – Archives**

- Should the “Markings on the Journey” 2-minute video of the co-founders that was donated be added to the archives? Yes, substantial unanimity.
- Discussed topics for the 2020 conference (most popular choices were: always inclusive, never exclusive; cultural diversity-who is not in the room and why; and AA and social media.
- Discussed policy and admissions for dealing with special requests, outside of GSO trustees
- Review of archives workbook – no revisions needed

#### **Panel II – CPC**

- Discuss AAWS LinkedIn page. No, substantial unanimity. However, the page is already in the works.
- Consider request to removed text “They may help arrange hospitalization” from the pamphlet “Alcoholics Anonymous in Your Community.” (pgs. 90-91). Yes, substantial unanimity.
- Review Content of C.P.C. Kit and Workbook. (pg. 92)

#### **Panel III – CEC**

- Consider request to develop a Fifth Edition of the book Alcoholics Anonymous. (pgs. 153-159). Yes, substantial unanimity in making changes to the stories only. More relevant to the newcomer, more inclusive and diverse.
- Consider the development of a Literature Committee Workbook. (pgs. 165-175). No, substantial unanimity
- Consider request to revise the pamphlet “The A.A. Group.” (pgs. 262-263). Yes, substantial unanimity to revise/add 2 questions: “Do group members treat one another with respect?”, and “Do you feel safe in AA?” (physical aspects, anonymity).

### **Panel VI – Corrections**

- Consider request for a review of all corrections related literature in order to make the language more modern and inclusive. (pgs. 95-96). No, substantial unanimity.
- Consider request that the General Service Office establish and help maintain a database of Correctional Facilities in each service area in the U.S. and Canada and the status of meetings held therein. (pgs. 97-99). No, substantial unanimity.
- Review contents of Corrections Kit and Workbook. (pgs. 100-102)

### **Panel V – Grapevine**

- Consider the list of suggested AA Grapevine book topics for 2020 and later. (pgs. 115-118). Yes, substantial unanimity.
- Consider request to remove the “Alcoholism at Large” section from AA Grapevine. (pg. 573, pgs. 119-140, pgs. 574-579). No, substantial unanimity.

### **Panel VI – Mynah Bird**

- Consider revising the Foreword to the book Twelve Steps and Twelve Traditions. (pgs. 271-275). No, substantial unanimity.
- Consider suggestions to add “nonalcoholics may attend open meetings as observers” to the end of the open meeting side of the Primary Purpose (blue) card. (pgs. 276-278). Divided, approximately half yes and half no.
- Consider request to update the pamphlet “The Twelve Steps Illustrated.” (pg. 279). Yes, substantial unanimity.

### **Panel VII – Public Information**

- Public Service Announcements (PSA’s): Consider request that the video PSA “My World” be discontinued. (pg. 425). Yes, substantial unanimity. Consider request to approve the development of a new PSA in video format that utilized full-faced actors (not members of A.A.). (pgs. 426-439). Yes, substantial unanimity.
- Review draft language addressing anonymity and safety proposed for the pamphlet “Understanding Anonymity.” (pgs. 440-442). Reviewed.
- Consider request to update language in the flyer “A.A. at a Glance,” (pgs. 443-445). Yes, substantial unanimity.
- Review contents of P.I. Kit and Workbook. (pg. 460). Reviewed.

### **Panel VIII – Treatment**

- Consider revising the pamphlet “Bridging the Gap” to include related corrections activities (pgs. 477-483). 50/50 split in agreement/non-agreement.
- Consider adding a story from an A.A. member who is deaf to the pamphlet “Access to A.A.: Members Share on Overcoming Barriers.” (pgs. 484-485). Yes, substantial unanimity.
- Consider updating the pamphlet “A.A. for the Older Alcoholic – Never too Late.” (pg. 486). Yes, substantial unanimity.

### **Panel IX – Website**

- Review suggested area contributions for delegate expense for the Conference. (pgs. 105-106). Reviewed.
- Review the Conference – approved level of \$5,000 for individual bequests to the General Service Board from A.A. members. (pgs. 107-108). Reviewed. Agreed no changes needed. Reminder, these are contributions, not donations. There is no limit to what a group can contribute, a member can always contribute to the group and the group can turn around and contribute to GSB should there be an amount above \$5,000.
- Review the Conference approved maximum annual contribution of \$5,000 to the General Service Board from an individual A.A. member (pgs. 109-110). Agreed no changes needed.
- In speaking about expenses and contributions, the following thoughts were brought to the surface: AA needs my gratitude, not my money, we have expenses – no dues or fees, on birthdays hand out the GSO contribution envelopes, how much did a cup of coffee cost in 1935 vs. now?

### **Panel X – Conference Committee on Annual Hawaii Convention Committee**

- Discuss anonymity – protected photograph of the flag ceremony to be taken at the 2020 International Convention. (pg. 545). Yes, substantial unanimity.
- Consider a broadcast of the 2020 International Convention Opening Flag Ceremony, similar to the anonymity – protected delayed Internet broadcast of the 2015 Internal Convention Opening Flag Ceremony. (pgs. 546-547). Yes, substantial unanimity.
- Discuss ways to encourage interest in Regional Forums and attract first-time attendees. (pgs. 548-572). Ideas included saving \$20/week to be able to attend the Las Vegas Forum in 2020, and invite a friend!

### **Panel XI – Policy / Admissions**

- Consider a process for how a Conference committee could review, discuss and act on proposed agenda items not forwarded to a Conference. (pgs. 297-343). Yes, substantial unanimity.
- Discuss a request to develop a procedure to deal with special requests/agenda items. (pgs. 347-355). Yes, substantial unanimity.

### **Panel XII – DCM' and Intergroup Chairs (finance)**

- The committee I worked on during our lunch break – I sat in on the finance committee to review the 2020 budget. We upped some of the travel costs for our trusted servants, including meal costs.
- In speaking about expenses and contributions, the following thoughts were brought to the surface: AA needs my gratitude, not my money, we have expenses – no dues or fees, on birthdays hand out the GSO contribution envelopes, how much did a cup of coffee cost in 1935 vs. now?
- If groups and/or districts want a budget report, they can request one and one will be provided.

At that point, there were Area Officer reports, of which I reported on behalf of District 6. Thank you Janice for putting together a written report for me to deliver.

During the assembly, the delegate prepared a brief summary of what she interpreted over the course of the assembly, for what she is to take into consideration with her when going to serve at the GSC.

The assembly itself was peaceful! It was wonderful to be surrounded by others in service, to watch and learn from those around me who exude humility and service in ways that are truly beautiful and unique to Alcoholics Anonymous. I learned a tremendous amount about how we inform our Delegate, and about all of the many topics that will be covered at the GSC.

Additionally, my homestay was a lot of fun – sharing a 3-bedroom house with 9 alcoholics was pretty entertaining, fun, and I met a lot of new people. Thank you for providing me with the opportunity to be a part of service at this level.

Our Delegate, Colleen, will be on Kauai July 4<sup>th</sup>, speaking about her experience at the General Service Conference, at the Hui Ohana 4<sup>th</sup> of July celebration. We hope you can all attend!

We are pleased to announce that Alcoholics Anonymous World Services, Inc., has recently licensed the "Meeting Guide" technology. The Meeting Guide app was launched in November 2015. The app provides a platform for local A.A. entities (areas, intergroup/central offices, districts, etc.) to post their local A.A. meetings, and currently provides information to more than 100,000 users reflecting some 86,000 meetings. Since the meeting information is all made available through the app's mobile-friendly interface, those looking for a meeting have a simple, one-stop place to look.

The collated meeting information will be available in the future through G.S.O.'s website, [www.aa.org](http://www.aa.org), and will be a component of the proposed A.A.W.S. app. The intent of incorporating the Meeting Guide component is to make it easier for members to find A.A. meetings.

A.A. intergroup/central offices, districts and areas that provide online meeting lists are invited to have their meetings displayed through the Meeting Guide. If you are already synchronizing your meetings through the Meeting Guide app there is no additional action necessary. When the new aa.org website launches at some point in 2019, your information will be seamlessly included.

Please note the meeting information database will operate completely independently from the Fellowship New Vision (FNV) database that is currently supported by the General Service Office. The Meeting Guide is a separate tool that offers districts, areas or intergroup/central offices full control of their local meeting information and collects it in one place for all to find. Users of this new portal will be linked to the service entity providing the information. Participation is, of course, voluntary, but the more connected the service is to the Fellowship as a whole, the more powerful a tool it will become.

The current listing of A.A. entities in "A.A. Near You" on aa.org will not be impacted. Those looking to contact A.A. in their community will still have access to the information that is currently available on the site.

We have developed instructions about how to connect with this new resource at <https://meetingguide.aa.org>. If you have any questions about this initiative or how to synchronize your meetings to this database, dedicated support is in place.

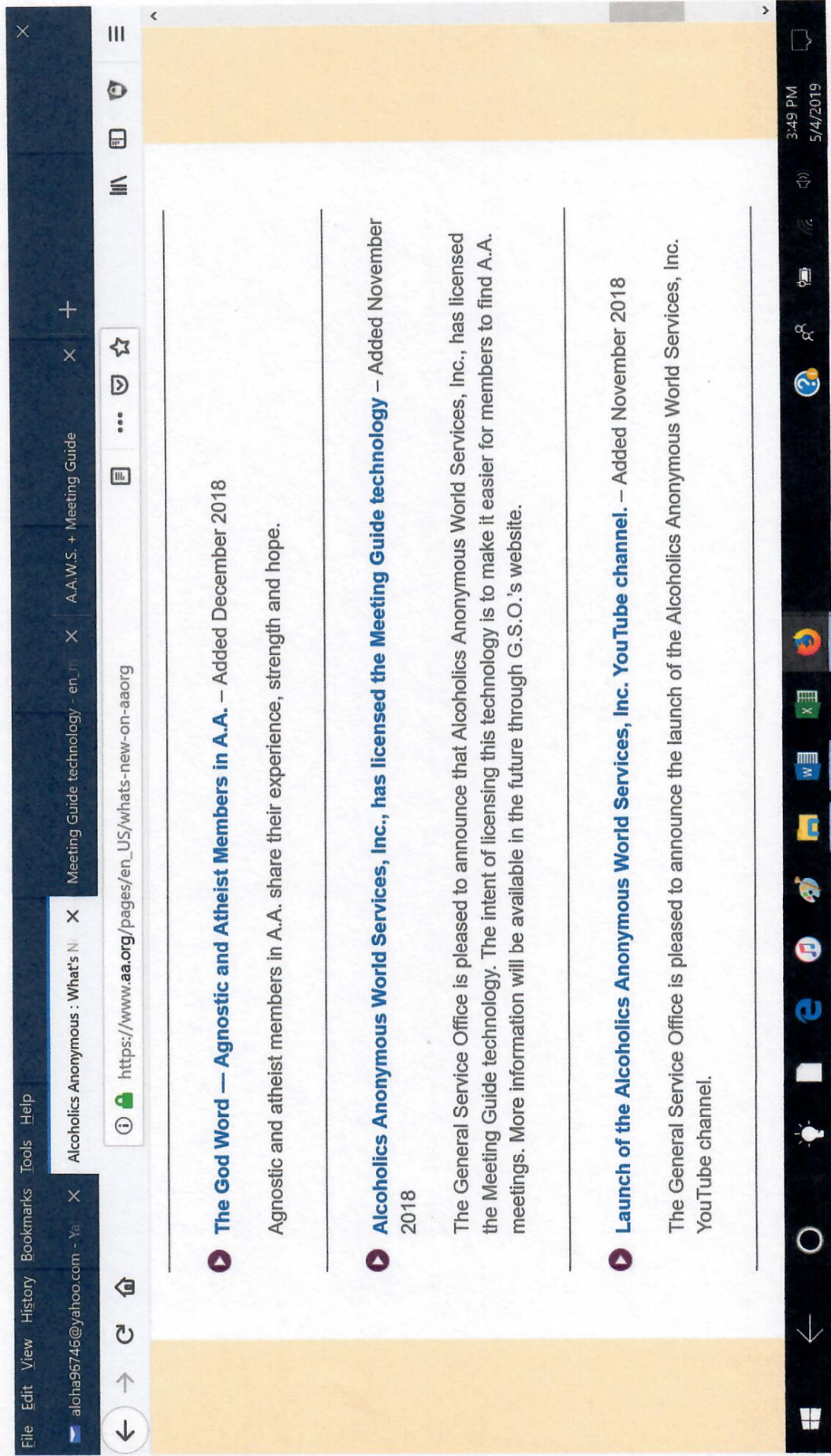
Our content policy may include the following:


