"Were entirely ready to have God remove all these defects of character."

He said: Now that the fifth step is complete, my sponsor tells me the work begins. What the hell does he mean by that?

Well I get up in the morning and look in the mirror and I'm facing a character whose defects I don't understand but, the book says alcohol is better a symptom. Now I have to look at life from a different perspective and what I see is a character who has many attributes as well as defects. So what am I supposed to do?

First of all, I have to look at my major character defect, Developing human relationships. So I show up to meetings still suffering, all the symptoms of a real alcoholic, and now I have to hold out my hand and establish relationships.

For me, the easiest part of this would be to be of service because everything I did prior to that was all about me myself and I so I started getting into service the simple part carrying the coffee to the meeting. And then putting out my hand and leaving someone new, welcoming them to a new world with my feet planted on the Ina.

I got sober on the beach and it's been interesting watching people come through the room with no walls, not knowing what sobriety is like for me and listening to their story but not having to experience that character defect that they're expressing at a meeting.

That's part of becoming a student a learner Because the more I learn the easier it is to become a companion on the journey to sobriety listening skills. Those other character defects that I have, I have to work on them too, but I do that by not taking over my meeting and letting other people express their life experience.

She said: I used to think Step Six meant becoming perfect or instantly transformed. But over time, I've come to see that the real challenge lies in my delusion—the belief that I can manage my character defects on my own, or that some of them still serve me. I often cling to patterns like control, people-pleasing, jealousy, and self-righteousness under the illusion they protect me. But these aren't strengths; they're symptoms of fear and

My ego tells me I should already be better. That I shouldn't need help. That certain defects—like judgment or control—are just part of who I am, even necessary for survival. But that thinking blocks my growth. Step Six asks for a deeper humility—not humiliation, but honest surrender. I am not God. I can't fix myself. But I can become willing.

Willingness is the heart of this step. God's role is everything. I don't remove my defects—God does. My job is to be entirely ready, not to force change or achieve perfection. As the Big Book says, "If we still cling to something, we ask God to help us be willing." That reminds me: willingness is a process. I don't have to feel ready. I just have to invite God in. As the Little Red Book says, "We gain the willingness to be freed from old willful thoughts and habits." I don't fight my way to freedom—I let God carry me.

My sponsor tells me that willingness is enough. This step isn't about becoming flawless—it's about making progress. She helps me see how clinging to familiar defects is just another form of self-sabotage. She'll ask if I'm willing to practice the opposite: compassion instead of resentment, faith instead of fear, trust instead of control. She'll ask if I've prayed—if I've gotten on my knees, like it says on page 76.

She Said (cont) **The Promises** of Step Six are powerful: emotional relief, inner peace, and clarity. The Little Red Book speaks of "release from tension and anxiety." The Twelve and Twelve reminds us that "the grace of God can enter and expel the obsession." When I become willing—even imperfectly—I open the door to transformation.

The solution lies in spiritual partnership with my Higher Power: letting go again and again with honesty and willingness. Sometimes, it means acting "as if" until my heart catches up. As Joe and Charlie say, "If I want God to take away selfishness, I must practice unselfishness." This is the work—showing up, praying, asking for help, and doing the opposite of what the defect wants me to do.

Today, I pause before I react. I ask for help when fear or jealousy rises. I name the defect, get honest, and become willing to let it go—even just for today. I don't have to be perfect. I only have to be willing.

June in Our History:

June 10, 1935: Dr. Bob who becomes AA's co-founder takes his last drink on this date. June 10^{th} is considered by most AA members and historians as the Birthdate of AA.

June 28, 1935: In the hospital Bill W. and Dr. Bob confront Bill D., a well known attorney in Akron, strapped down on a bed. (**He will become AA # 3**.)

June 1940: "The Serenity Prayer" is found in the N.Y. Tribune newspaper by two members and brought into our N.Y. office. Bill W. liked it so much it was re-printed and sent out with all replies to inquiries about AA from that day forward.

June 1947: This issue of The Grapevine carried for the first time, the AA Preamble, written by the Grapevine's editor, Tom Y.

June 11, 1971: Ernie G. died. He was "AA #4". Married Dr. Bob and Anne's daughter Sue but could not hold onto his sobriety and the marriage fell apart.

June 1994: Our AA Grapevine celebrated it's 50 years of continuous publication!

June 14, 1999: Time Magazine" special issue. The 100 most influential people of the 20th century. Bill W. is included with a well written article by reporter Susan Cheever.
