

After much consideration, the Board of Directors has voted to host Lake and Trails fall camp as a one day program for attendees without a group overnight stay. In order to allow for social distancing and provide a great experience this means some children will attend on Friday and others will attend on Saturday, as two one day camps are necessary. The registration form below will walk you through confirming attendance for the correct day for your child/children. Here is an overview of what to expect:

•1st and 3rd year event date is Friday, October 2

•2nd and 4th year event is Saturday, October 3

•7:30am – 8:30 Check In

•8:30 am - 6:30 pm program

•All classes will be outside with lots of shooting

•Hunter Education Course and Ohio Boater Education Course are not offered this year so 1st and 3rd year attendees will have other activities

•Attendees will be divided into small groups for safety and more range time

•A boxed lunch will be the only provided food, please plan accordingly

•All state and local health and safety guidelines will be followed

•Ear plugs, safety glasses, and a mask will be provided for each child and sponsor

•All program participants must leave at the end of the day, no one is permitted to stay overnight

•There will be a maximum attendance of 36 children per year

•Cost will be \$35 per child* and \$50 per adult *Because of generous donations from supporting clubs the fee for your child has been covered this year with a scholarship.

•Registration begins July 15th.

•The adult fee of \$50 is required at the time of registration to secure a spot in the program.

•Youth Assistant Instructor opportunities are available for each day

We realize these changes may result in more driving time for parents who have children attending on both Friday and Saturday and are committed to making sure the effort is worth your while. Please read the following **Code of Conduct/ Camp Rules**. If you agree with and are willing to comply with all of the expectations of the **Code of Conduct/ Camp Rules** and Lake and Trails Organization Youth Fishing Camp, please sign below.

Accompanying Adult: Please read the following **Code of Conduct**/ **Camp Rules**. Please sign the bottom of this form to show your intent to support the implementation of this **Code of Conduct**/ **Camp Rules** in regards to your youth at camp.

- I will be expected to participate in all aspects of the camp program and to follow the daily camp schedule.
- Smoking is prohibited in all buildings and by anyone less than 18 years of age.
- Alcohol is prohibited in the camp during camp programs.
- Possession of recreational/ illegal drugs and dispensing of prescription drugs without proper authorization will result in immediate expulsion.
- If a youth is expelled from the program, the accompanying adult and other youth under that adult must also leave the program, or arrangements must be made for a parent to come and pick up the youth expelled immediately.
- I am personally responsible for the equipment I use from the camp, and will pay for damaged or lost equipment.
- I will conduct myself with respect towards other campers, instructors, staff, so that I may also be respected.
- Swimming will be prohibited during camp program.
- Personal firearms or ammunition are not allowed in the camp without authorization from Lake and Trails Committee.
- All vehicles must be parked in designated areas. Only authorized Instructors, Committee Members and Camp personnel may use golf carts, UTV, and ATV vehicles if registered ahead of time. If seeking special permission to use an ATV, UTV, or golf cart please contact Joe Lukcso at Joe@lakeandtrails.org.
- No unauthorized pets may be brought to camp.
- Only registered guests of the program, invited guests or instructors are permitted in camp during the program.
- Youth must wear their wrist bands at all times on the outside of their clothing, clearly visible at all times.
- Youth and Parents will stay for the entire program day, unless previously discussed with Committee.
- All state and local mandates regarding health safety and Covid19 must be adhered to by all youth, adults and Instructors present.
- Refunds will be made 4 weeks prior to camp, no refunds will be given at camp or for expelled individuals.
