

Club GBA: Bylaws and Membership Requirements

This document outlines the bylaws for Gel Blaster Arena PTY LTD, with the internal club running under the company umbrella, named Club GBA. It includes details on membership requirements, including the mandatory annual membership fee, and the utilization of club fees.

1. Club Name and Purpose

The official name of the club is Club GBA, operating under Gel Blaster Arena PTY LTD. The purpose of Club GBA is to promote safe, enjoyable, and organized gel blasting activities, fostering a community of enthusiasts who share a passion for the sport.

2. Membership Requirements

To become a member of Club GBA and gain access to Gel Blaster Arena, individuals must meet the following requirements:

- All customers are required to purchase an annual membership fee of \$20.
- Members must agree to adhere to all club bylaws, rules, and regulations.
- Members must participate in an orientation session outlining safety procedures and club policies.

3. Membership Fees

Key points on meetings and voting include:

- Annual General Meeting (AGM): Held once a year to review club activities, financials, and elect the Board of Directors.
