

# Gel Blaster Arena: Duty of Care for Underage Accompanied Minors

---

This document outlines the duty of care policies and procedures for Gel Blaster Arena regarding underage accompanied minors. These policies ensure the safety and well-being of all participants aged 10-17 years who must be accompanied by an adult guardian, carer, supervisor, or sibling over 18 years of age.

## 1. Age Limit and Supervision Requirement

Gel Blaster Arena welcomes participants aged 10-17 years, provided they are accompanied by a responsible adult guardian, carer, supervisor, or sibling over 18 years of age at all times.

- Minors aged 10-17 must be accompanied by an adult at all times, including during gameplay, breaks, and overnight stays. Unless otherwise authorized by Gel Blaster Arena management.
- The accompanying adult is responsible for the minor's safety and well-being throughout the event or activity.

## 2. Responsibilities of Accompanying Adults

The accompanying adult has the following responsibilities:

- Ensure the minor adheres to all safety rules and guidelines set by Gel Blaster Arena.
- Supervise the minor during all activities, ensuring they do not engage in any dangerous or inappropriate behavior.
- Be present on-site at all times during the event or activity, including overnight.
- Take immediate action if the minor requires medical attention or if there is an emergency.

If the accompanying adult needs to leave the event or area for any reason, the minor must remain in their care at all times.

## 3. Safety and Well-Being

Gel Blaster Arena is committed to providing a safe environment for all participants. The following measures are in place to ensure the safety and well-being of underage minors:

- All activities are supervised by trained staff to ensure compliance with safety protocols.
- First aid facilities are available on-site, and staff are trained to handle medical emergencies.
- Emergency contact information for the accompanying adult must be provided during registration.
- Emergency medicine must be carried by the Adult at all times or easily accessible i.e.: Adrenalin EpiPens, salbutamol asthma inhaler etc.

#### **4. Legal and Liability Considerations**

By accompanying a minor to Gel Blaster Arena, the adult guardian, carer, supervisor, or sibling assumes responsibility for the minor's actions and well-being. Gel Blaster Arena is not liable for any incidents or injuries that occur as a result of the minor's participation in activities.

#### **5. Acknowledgment and Agreement**

All accompanying adults must acknowledge and agree to the following terms before participating in any Gel Blaster Arena activities:

- I understand and agree to the duty of care responsibilities outlined in this document.
- I will ensure the minor in my care adheres to all safety guidelines and rules.
- I will remain on-site at all times during the event or activity, including overnight, and take full responsibility for the minor's safety and well-being.
