

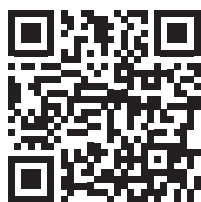

2. Shall the City approve the proposed Charter Amendment summarized below relative to the increase in membership and appointment of Nashua Police Commissioners by the Mayor and the President of the Board of Aldermen upon approval of the Board of Aldermen?

The amendment changes the membership of Nashua Board of Police Commissioners from three commissioners appointed by the Governor, with the advice and consent of the Executive Council, to five commissioners with three appointed by the Mayor and two appointed by the President of the Board of Aldermen and all confirmed by the Board of Aldermen. Appointments shall be based upon qualifications, merit and record of community service and should be balanced so that the membership of the Commission reflects the citizenship of the City. Members of the immediate family of and residents of the same household with the Mayor and any Alderman would be ineligible.

Omitted from this ballot summary is the language in the proposed change that allows for the removal of Police Commissioners without cause.

- This change is not about local control. It's about total control by City Hall. Removal without cause **will create a revolving door of police commissioners** each serving at the will of city hall.
- **Appropriate control and transparency already exist.** The Board of Aldermen already must approve the police budget. Anyone can nominate an individual to be commissioner (though the mayor never has). The commissioners must be Nashua residents. Commissioner meetings are open to the public.
- Nashua is the safest city in New Hampshire and third safest in the country. The Nashua Police Department is held out as a standard for other police departments. **Why would we change it to be like other departments?**
- **The Board of Aldermen already rejected this change** and created a study committee to review the issue, invite public input as well as police input, and review multiple commission structures. The voters are not being presented with the whole story or a thoughtful approach to change. **Why would we rush this without proper review and options being presented?**
