



Inkdoc Productions Contestant Release of Liability Agreement

This Release of Liability ("Release") is entered into by the undersigned participant ("Entrant") as a condition of participation in the contest hosted by Ink Doc Productions ("Company"). By signing below, Entrant acknowledges, understands, and agrees to the following terms:

1. Assumption of Risk

Entrant acknowledges and accepts the inherent risks associated with travel (domestic or international) and tattooing, including but not limited to injury, infection, scarring, allergic reactions, dissatisfaction with the tattoo outcome, theft, or other harm or loss arising from participation in this contest and related activities. Entrant voluntarily assumes all risks, whether foreseen or unforeseen, associated with participation.

2. Release of Liability

Entrant agrees to release, waive, discharge, and hold harmless Ink Doc Productions, its owners, employees, agents, contractors, affiliates, successors, and assigns (collectively referred to as the "Released Parties") from any and all claims, demands, damages, injuries, losses, costs, or liabilities, whether direct or indirect, that may arise from Entrant's participation in the contest, travel, tattooing, or streaming/televised production of the event, including but not limited to negligence by any of the Released Parties.

3. Modification, Postponement, or Cancellation

Entrant acknowledges that Ink Doc Productions reserves the right to modify, postpone, or cancel any trip or contest-related activity at its sole discretion. In the event of cancellation or postponement, winners will be provided the option to attend a future trip. No additional compensation will be provided to winners in such circumstances.

4. Judges' Decisions

Entrant agrees that all contest decisions made by judges are final and binding. No appeals or disputes will be entertained regarding the outcomes of the contest.

5. Use of Likeness and Media

Entrant grants Ink Doc Productions and its affiliates the perpetual, worldwide right to use their photos, likeness, videos, and any other media captured during the contest and related activities for promotional, advertising, and production purposes. Entrant understands and agrees that no compensation, royalties, or other payments will be provided beyond the airfare, lodging, meals, and tattooing outlined in the contest rules.



6. No Additional Compensation

Entrant acknowledges that participation in the contest and receipt of prizes (airfare, lodging, meals, and tattooing) constitutes full and complete compensation. No additional remuneration will be provided under any circumstances.

7. Governing Law

This Release shall be governed by and construed in accordance with the laws of the jurisdiction in which Ink Doc Productions is headquartered, without regard to its conflict of law principles.

8. Acknowledgment of Understanding

By signing below, Entrant affirms that they have read and understand this Release in its entirety and agree to its terms freely and voluntarily. Entrant further acknowledges that they are at least 18 years of age and fully competent to sign this Release.
