**SWIMMING IS AT YOUR OWN RISK. YOU ARE RESPONSIBLE FOR ANY  
SMALL CHILDREN THAT YOU BRING AS YOUR GUEST. YOU ARE TO  
KEEP YOUR EYES ON THEM AT ALL TIME.**

USE OF PINEBLUFF LAKE AND ITS' SURROUNDING AREAS IS LIMITED TO RESIDENTS, OR PROPERTY OWNERS OF PINEBLUFF, THE ETJ, (EXTRA-TERRITORIAL JURISDICTION), CUSTOMERS ON TOWN'S WATER SYSTEM, AND MEMBERS OF THEIR FAMILIES AND THEIR GUESTS; TOWN OF PINEBLUFF EMPLOYEES AND THEIR FAMILIES; VOLUNTEER MEMBERS OF PINEBLUFF FIRE DEPARTMENT; AND MEMBERS OF TOWN OF PINEBLUFF APPOINTIVE BOARDS AND THEIR FAMILIES. FAMILIES THROUGHOUT MOORE COUNTY. SPONSORS ARE RESPONSIBLE FOR THEIR GUEST.

**ALL COOLERS ARE SUBJECT TO BE SEARCHED.**

**PLEASE FOLLOW THE RULES AND HAVE AN ENJOYABLE TIME AT  
PINEBLUFF LAKE.**

ANY ONE AUTHORIZED TO USE LAKE FACILITY MUST PURCHASE A LAKE PIN FROM THE TOWN HALL. **(Each person over the age of twelve (12) years who is authorized by the Town Ordinance-Section 18-1 to use the lake facilities is required to purchase annually a Lake Pin for admittance to said facility.)**

**SWIMMING IS PROHIBITED BETWEEN THE HOURS OF SUN DOWN TO  
SUN UP.**

SWIMMING IS PERMITTED ONLY IN DESIGNATED AREAS.

PROPER SWIM ATTIRE FOR FAMILY ORIENTED LAKE (NO THONGS)

LAKE FACILITIES ARE CLOSED BETWEEN THE HOURS OF **SUNDOWN TO  
SUN UP DAILY**

LAKE PINS MUST BE DISPLAYED AT ALL TIMES.

**YOUR LAKE PIN MUST BE AVAILABLE FOR LAKE ATTENDANT.**

MAXIMUM OF **FOUR (4)** GUESTS PER LAKE PIN.

GUESTS MUST FOLLOW ALL LAKE RULES AND GUESTS MUST LEAVE WHEN  
PIN HOLDER LEAVES.

LAKE PINS MAY **NOT** BE PASSED ON TO OTHERS.

CHILDREN UNDER 12 MUST HAVE ADULT SUPERVISION. **FOUR CHILDREN MAXIMUM ALLOWED PER ADULT PIN HOLDER (THEY WILL NOT BE COUNTED AS A GUEST).**

LAKE VISTORS UNDER THE AGE OF 16 MAY NOT HAVE ANY GUEST WITHOUT ADULT SUPERVISION (ADULT = OVER THE AGE OF 18).

RUDE OR OBNOXIOUS BEHAVIOR; LOUD, DISTURBING OR UNNECESSARY NOISES; FAILURE TO OBSERVE SAFETY PRECAUTIONS; OR FAILURE TO ABIDE BY THE RULES MAY BE CAUSE FOR EXPULSION FROM THE LAKE AREA, AND MAY RESULT IN ADDITIONAL LEGAL PUNISHMENT.

SWIMMING IS AT YOUR OWN RISK.

**NO SMOKING OR VAPING OF ANY SUBSTANCES (NO TOBACCO PRODUCTS OF ANY KIND) IN THE SWIM AREA, ON THE PIER, OR AROUND THE VICINITY OF THE SWIM AREA, THE PAVILLON, OR THE PARKING LOT.**

**ALCOHOLIC BEVERAGES AND DRUGS ARE STRICTLY FORBIDDEN.** POSSESSION OF ALCOHOLIC BEVERAGES OR DRUGS OR BEING ON TOWN PROPERTY WHEN IN AN IMPAIRED STATE DUE TO PREVIOUS CONSUMPTION OF ALCOHOLIC BEVERAGES OR DRUGS IS PROHIBITED AND IS PUNISHABLE BY ARREST AND/OR FINE. **ALL COOLERS ARE SUBJECT TO BE SEARCHED.**
