

****Terms & Conditions (“T&C”)**

HIGH FLYERS 50 – GLOBIZ AWARDS**

The **HIGH FLYERS 50 – GLOBIZ AWARDS** (“HF50 Globiz Awards” or “Awards”) are administered by **Eventinity Ventures UK Limited (“EVL”)**, which is responsible for the nomination process, evaluation, and final selection of award recipients.

By submitting a nomination or participating in any capacity, each participant (“Participant”) acknowledges and agrees to comply with and be legally bound by these Terms & Conditions. EVL reserves the right to amend, modify, or update these T&C at any time without prior notice.

1. Award Categories

1.1 Business Category

This category is open to individuals or organizations that have established and are actively operating a business.

- The business must have been in existence for **a minimum of 2 years** as of **April 1, 2026**.
- Businesses from all sectors are eligible, subject to compliance with applicable laws and ethical practices.

1.2 Professional Category

This category is open to individuals employed as trained professionals in any recognized field. Eligible professionals may include (but are not limited to):

MBAs, Doctors, Engineers, Advocates, Chartered Accountants, Teachers, Fashion Designers, Jewellery Designers, and other qualified professionals.

- The Participant must have **a minimum of 2 years of professional experience** as of **April 1, 2026**.

1.3 Category Modifications

The Jury and Awards Management may, at their discretion:

- Change, modify, split, merge, increase, reduce, or cancel categories,
- Adjust the number of awardees in any category,
Based on the quality and volume of entries received.

Submission of a nomination **does not guarantee selection**. No inquiries or challenges regarding the shortlisting or selection process will be entertained.

2. Participation Requirements

2.1 Data Usage

By participating in the Awards, Participants irrevocably authorize EVL to collect, store, process, and use all submitted data.

This information shall be the exclusive property of EVL and may be used for:

- Marketing and promotional activities,
- Public relations and corporate communication,
- Advertisements, award announcements, and event-related publications.

EVL may use such data with or without EVL branding.

2.2 Accuracy of Information

If any information submitted by a Participant is found to be inaccurate, incomplete, false, or misleading at any time—before, during, or after the Awards—the Participant may be:

- Disqualified, and/or
- Required to return the Award and any associated recognition.

The Jury and Awards Management shall have full and final authority to determine the accuracy and fairness of information submitted.

2.3 Voluntary Participation & Limitation of Liability

Participation in the Awards is voluntary.

EVL shall not be liable for any loss, damage, cost, or expense incurred by Participants before, during, or after the Awards.

No financial compensation or payment shall be due to Participants for participation or attendance.

2.4 Intellectual Property & Usage Rights

By submitting an entry, the Participant grants EVL a **royalty-free, irrevocable, non-exclusive, worldwide, non-transferable license** to use, reproduce, publish, and display:

- The submitted entry,
- Any materials, content, or intellectual property arising from participation, and
- Event photographs, videos, and coverage,

In any print, digital, or electronic format, including press releases, websites, social media, and promotional campaigns.

2.5 Proof of Country-Specific Eligibility

Participants applying for awards in a specific country must submit **proof of stay or residency**, such as relevant passport pages or equivalent documentation. Failure to furnish valid proof may result in disqualification.

3. Nomination Process

- Participants must submit nominations through the official website: www.highflyers50.com
- Nomination submission is **free of cost**.
- The deadline for submission is May **1, 2026**, unless extended at EVL's discretion.
- Late submissions may be accepted solely at the discretion of Awards Management.
- EVL reserves the right to change the event date without prior notice.

4.1 Fee Structure

Final winners will be required to pay applicable fees for:

EVL reserves the right to waive or reduce fees for honorary recipients or at its discretion.

4.3 Binding Confirmations

An email confirmation from the Participant shall be considered a **binding commitment**, and the agreed amount shall remain payable regardless of subsequent changes or withdrawal.
