Cache Creek Nature Preserve “Experience the Creek” Visit Program Guidelines

By signing below, I, the teacher/program leader, agree to:

Before the field trip:

- Turn in a complete reservation form to reserve my spot, including my contact information, preferred field trip date followed by a first and second alternative, time of visit, number of students and chaperones, and my choice of activities.
- Sign up only one class per day (if you are signing up for two or more classes, you will need two or more field trip dates).
- Respond within three (3) business days to all communications from the Cache Creek Conservancy.
- If needed, find parent chaperones willing to lead stations on the day of the field trip.

On the day of the field trip:

- Bring a minimum of one (1) parent chaperone for every six (6) students.
- In addition, activity groups larger than seven (7) students will need two (2) parent chaperones per group. Classes are usually split into four (4) activity groups.
- Bring a check/cash in the amount of the invoice sent to me prior to my field trip *if my class is signed up for a station with a fee*

After the field trip:

- Complete the Experience the Creek evaluation sent to me through email within five (5) business days of receiving the email

I have read and agree to follow the above guidelines. I understand that a failure to do so could result in cancelation of the field trip or future field trips.
