



NON-REFUNDABLE RESERVATION FEE AGREEMENT

PUPPY LETTER OF INTENT

This is a mutual agreement signed along with payment of your \$500 reservation fee (per puppy) paid in full to secure your reservation spot on our waitlist for a puppy from Growing Great Goldens. We do not secure your reservation for a puppy without this. I understand that this reservation fee will be put toward the total cost of a puppy. In order for your \$500 non-refundable waitlist reservation fee to be accepted, please agree to the following terms:

Puppy Waitlist Reservation Fee: \$500

1. I understand & agree that my \$500 reservation fee is non-refundable. I am not guaranteed my puppy of choice or gender of choice; however, I understand that I can continue to defer my place in line and add myself to future reservation lists until I get the puppy I want and/or need.

_____ I understand and agree to the terms and conditions.

2. I also understand that the timing of litters is uncontrolled, as well as a successful pregnancy. We are not able to control the timing of heat cycles. We retain the right to adjust breeding pairs at any time. We also have the right to cancel a reservation due to the best interest of the parents involved (the health of our parent dog(s) is paramount to having a litter).

_____ I understand and agree that timing is never guaranteed.

3. I understand that clients choose in the order of the reservation list and clients can choose any of the puppies available to them at their selection time and placement. If a client is not in attendance nor is reachable by phone during their 30-60 min selection timeframe, then they will forfeit their placement.

_____ I understand and agree to the selection day process.

4. When clients pay a non-refundable reservation fee, they are allowed to be on two reservation lists concurrently and ONLY choose ONE puppy. If I want two puppies, I understand that two deposits are required. Once I select my puppy, I will be removed from the other reservation list. I understand that I cannot use the second spot for a friend or family member. This fee secures my spot on the waitlist for a puppy from Growing Great Goldens. The order that you submit your reservation fee in, secures your reservation number on the current litter's waitlist.

_____ I understand that my reservation fee places me on two lists; the upcoming litter waitlist (in the order of fee received) and the master waitlist for a puppy from Growing Great Goldens; however, that is only for ONE puppy. When I choose my puppy, my name will be removed from the list(s). It cannot be transferred to someone else.

5. We reserve the right to use any puppy selections in any form or fashion without restriction. We also reserve the right to replace a client that chooses to remove themselves from the list with our own selection. Growing Great Goldens reserves the right to the first pick male and/or female of every litter.

_____ I understand and agree to Growing Great Golden's right to use their pick in any form or fashion they choose.

6. I am aware that puppies can have certain common ailments upon coming home. To include, but are not limited to things like urinary tract infections, parasites, ear infections, diarrhea, and allergy issues are all common. While we routinely de-worm and monitor for any of these potential ailments, sometimes the stress of leaving the breeder causes issues to flare up. I understand it will be my responsibility to treat and care for my new puppy once they leave the breeder.

_____ I understand that puppies can have certain ailments and I agree to ensure they get the proper care and medication, if needed.

7. I understand that I am full responsibly to pick up and/or arrange pick up of your puppy (or any transport) and agree to be responsible for all costs associated with picking up the puppy on selection day.

_____ I understand and agree to be responsible for all costs associated with picking up the puppy on selection day (either myself or a puppy nanny).

8. I agree to pay the reservation fee (for a total of \$500 per puppy) upon the request of the breeder at due time in order to maintain my reservation fee spot for puppy selection.

_____ I understand and agree to the terms and conditions of the reservation fee.

9. After paying the full reservation fee, I agree to continue to be in good communication with the breeder on selection day and pay for the puppy I've reserved in full (full cost of each puppy is \$3500). I understand and acknowledge that I am aware and prepared to pay the full amount of \$3500 for my puppy via an approved payment method with funds fully available to the breeder by the pick up day "Go Home Day" of my puppy. Puppy will not be released until funds are paid in full (& available funds, not pending). I understand that a minimum of \$50/day charge will incur for each day past "Go Home Day" that the puppy is in the care of Growing Great Goldens.

_____ I understand and agree to the terms and conditions of following through with the purchase of a puppy from Growing Great Goldens.

10. Growing Great Goldens reserves the right to void this transaction & refund the transaction for any reason. In the unfortunate event that your reserved puppy with this reservation fee should get too ill to complete the sale or die, Growing Great Goldens will give you the option of choosing a different puppy from this litter or holding your fee for the following litter (only up to 2 years from signed agreement date), if you choose to pass on subsequent litters, your reservation fee will be forfeited.
