# PUPPY COVENANT CONTRACT

Thank you for purchasing one of our precious puppies at Growing Great Goldens! In order to make sure everything is clear, please read this covenant contract; sign & date below only if you understand and agree to the following statements:

1. All sales are final. You should only buy a puppy if you are certain it is the one for you & that you are ready for the time commitment & financial responsibility of a puppy, & dog for its' entire life. Once we receive payment, no refunds are given.
2. Reservation Fees are not refundable. We do not reserve puppies without a fee & once received, we cannot refund it for any reason. \$500 Reservation Fee Pd on \_\_\_\_\_ Initial \_\_\_\_\_
3. Eight (8) week delivery/pick-up timing. Although you can purchase a dog before 8 weeks of age, we do not allow delivery/pick-up before 8 weeks of age, no exceptions. All shipping/delivery costs are buyers responsibility. If puppy is to be held for additional days after the scheduled "Go Home" day there is a \$50/day charge.
4. The puppies are sold as-is. We make no representations about the color, condition, trainability, or temperament of your puppy. No other agreements, promises, representations or warranties, express or implied have been made unless specifically stated in this agreement.
5. Puppy vaccinations & inspections. We will have the puppies inspected and vaccinated before pick-up/delivery by our licensed veterinarian. Once you take possession of your puppy, you are completely responsible for its care. If you find out that something is wrong with your puppy, please take it to a licensed veterinarian immediately. You should follow your veterinarian's recommendations for further treatment.
6. Limited Warranty. As a condition of purchase, you must get your puppy inspected by a licensed veterinarian within 48 hours of purchase/receiving your puppy. If the veterinarian says your puppy is unfit for sale due to sickness or a congenital defect, please bring it back & we will give you a full refund, providing that the puppy has not been injured or neglected in any way. "Sickness" does not include minor issues such as colds, allergies, internal or external parasites, umbilical hernias, puppy acne, innocent puppy murmurs, or the like.
7. The puppies are not licensed or microchipped. We recommend you contact your local department of animal services to license your puppy right away. It is up to your discretion and at your expense to get them licensed and/or microchipped. If you microchip your puppy, you agree to add our contact information to their microchip as well.
8. The puppies are not registered yet, but you agree to Register them immediately. Both Sire & Dam are registered purebred Golden Retrievers with the American Kennel Club (AKC). When we sell you a

puppy, we give you the paperwork to complete, at your own expense, so that you can register your puppy. Your puppy must be registered in your name as soon as possible. You are given *limited AKC registration rights* (no breeding rights) with the purchase of your puppy whether it's male or female.

9. No liability. We are not responsible for any claim or any liability, including any medical expenses incurred from the date of the sale and/or delivery/pick-up of this puppy. We hereby require that insurance (AKC or Trupanion is free for first 30 days) is activated for your puppy upon pick up/ receiving your puppy into your possession.
10. This puppy is fully yours & you are entering into a covenant. Upon receiving your puppy, we are trusting you to agree to love, care for, & responsibly steward this precious living creature. Proper training, safety, veterinary care, vaccinations, preventative care & proper housing, spay/neutering, nutrition & exercise is to be given to this puppy for the duration of its life. If for any reason you are unable to keep the puppy, we can help you place it in a proper home or you may return it to us, however, no money will be refunded, there may be a re-homing fee, & all expenses related to returning the puppy to us is at your own expense. You agree that at no point shall this puppy be relinquished to a shelter/pound or otherwise abandoned. Under no circumstance should the named puppy be involved in Breeding. Spay/neutering is advised & furthermore required by Growing Great Goldens, & is to be responsibly decided upon at your careful discretion as the owners of your dog with regard to timing.
11. Buyer acknowledges they have received the puppy into their possession on signed date beside signature below. Buyer accepts full ownership & financial responsibility of this puppy as a new member of your family.
