



# Ready Set Kinder Terms & Conditions

## **Terms and Conditions for Ready Set Kinder Pty Ltd**

These Terms and Conditions ("Terms") govern the use of Ready Set Kinder Pty Ltd ("School Readiness & Early Learning Program") and the relationship between Ready Set Kinder, the parents or guardians ("Parents" or "Guardians"), and the children ("Children") enrolled in the programs.. By enrolling a child in the School Readiness & Early Learning Program, Parents and Guardians agree to comply with these Terms.

### **1. Enrolment and Admission:**

- 1.1. Admission to Ready Set Kinder is subject to availability and is at the discretion of the management.
- 1.2. Parents or Guardians must complete all necessary enrolment forms and provide accurate information about the child's medical history, allergies, emergency contacts, and any special learning requirements.

### **2. Fees and Payment:**

- 2.1. Parents or Guardians are responsible for payment of all fees associated with Ready Set Kinder as outlined in the fee schedule provided upon enrolment.
- 2.2. Payment for each term is due in WEEK 2 and should be made through online transfer or prior arranged method. .
- 2.3. The Center reserves the right to revise fees with prior notice.
- 2.4 Failure to pay fees in accordance with due dates will result in the employment of a debt collection agency.
- 2.5 Ready Set Kinder will not cover any fees incurred by the employment of a third party to collect fees. All additional fees and charges will be passed on to the client.

### **3. Operating Hours:**

- 3.1. Ready Set Kinders operating hours are strictly set to the timetabled lessons.
- 3.2. Ready Set Kinder may offer additional learning programs beyond standard operating hours. Participation in such programs may be subject to separate fees.

### **4. Learning Programs:**

- 4.1. Ready Set Kinder offers various learning programs designed to enhance the educational development of enrolled children.
- 4.2. By enrolling, Parents or Guardians provide consent for their child's participation in these learning programs.
- 4.3. Ready Set Kinder will communicate the curriculum and objectives of these programs to Parents or Guardians in a

manner they see fit.

4.4. Parents or Guardians are encouraged to provide feedback and participate in discussions related to their child's educational progress.

## **5. Health and Safety:**

5.1. Children must be in good health to attend Ready Set Kinder, including participation in learning programs. Parents or Guardians should not send sick children to Ready Set Kinder to prevent the spread of illness.

5.2. Parents or Guardians must inform Ready Set Kinder of any allergies, medical conditions, or special learning requirements of the child.

5.3 In the event of a missed session, Ready Set Kinder will try to accommodate an alternative session at the discretion of teachers,

5.4 ALL make up sessions must be completed within 2 weeks.

5.5 Make up sessions will not carry over to the following term.

## **6. Behaviour and Discipline:**

6.1. Ready Set Kinder promotes positive behaviour and will address any disruptive or inappropriate behaviour, including during learning programs, in accordance with its disciplinary policy.

## **7. Termination of Enrolment:**

7.1. Either party may terminate the child's enrolment in Ready Set Kinder with written notice, subject to any applicable notice period and financial obligations.

7.2. Ready Set Kinder reserves the right to terminate a child's enrolment due to non-payment, chronic behavioural issues, inability to adequately cater to the child's learning needs or other reasons as determined by the management.

7.3 Terminating an enrolment by either party can occur at any point. Full fees are still liable until the end of the Term.

## **8. Privacy and Confidentiality:**

8.1. Ready Set Kinder will maintain the privacy and confidentiality of all information provided by Parents or Guardians, including personal, medical, and educational information.

## **9. Communication:**

9.1. Ready Set Kinder will communicate with Parents or Guardians regarding the child's progress in learning programs, activities, and any important updates related to education.

9.2 Communication extend, specifics and frequency is the discretion of the teachers at Ready Set Kinder, and subject to

their policies in each program.

**10. Property and Belongings:**

10.1. Parents or Guardians are responsible for providing and labelling their child's personal belongings. Ready Set Kinder is not responsible for lost or damaged items.

**11. Changes to Terms and Conditions:**

11.1. Ready Set Kinder reserves the right to amend these Terms with prior notice to Parents or Guardians.

**12. Governing Law:**

12.1. These Terms are governed by and construed in accordance with the laws of New South Wales (NSW), Australia.

By enrolling a child in Ready Set Kinder Pty Ltd, Parents or Guardians acknowledge that they have read, understood, and agree to abide by these Terms and Conditions.
