

Technician to wear a PPE visor while performing treatments that require close contact Reusable visors should be cleaned after each use; Technician to wear disposable gowns (over work clothes) where possible when performing treatments that can generate plume, such as using the e-file; For plume-generating treatments sufficient dust extraction is required.
