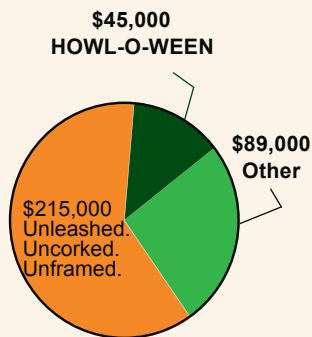

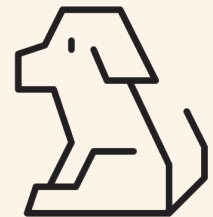
By the Numbers

- General liability Insurance must be \$1 million minimum. The City of Altamonte Springs must be listed as the certificate holder. City of Altamonte Springs, Emerson International Inc., Altamonte Mall, LLC, Brookfield Property REIT Inc, BPR REIT Services LLC, Brookfield Properties Retail, Inc., and Franklin's Friends must be listed as additionally insured
 - Nonprofits must provide proof of 501(c)3 status
- Rescue or shelter groups who have not received grant funding from Franklin's Friends must submit the rescue/shelter vetting form
 - All sponsors and vendors must complete the vendor liability waiver
- Franklin's Friends reserves the right to deny your application if your business operations are in conflict with our mission or policies
