**ACCIDENT WAIVER, RELEASE OF LIABILITY, ASSUMPTION OF RISK & PHOTO/VIDEO CONSENT**

**Adults 21+ Only | Public Venues & Private Residences**

This Accident Waiver, Release of Liability, Assumption of Risk, Indemnification, and Photo/Video Consent Agreement ("Agreement")

is entered into by the undersigned participant(s) ("Participant") in favor of Pineappless, its owners, directors, officers, employees, contractors, volunteers, representatives, agents, affiliates, successors, assigns, venue owners, and event hosts

("Released Parties").

Participant certifies they are twenty-one (21) years of age or older and legally permitted to consume alcohol. Participant acknowledges that alcoholic beverages may be made available, served, and/or brought by participants to the event. Pineappless does not sell alcohol. Participant voluntarily assumes all risks associated with the consumption of alcohol, whether provided, served, or brought by any party.

Participant understands and agrees that Pineappless has no duty to monitor, limit, supervise, or control alcohol consumption.

Participant is solely responsible for their own alcohol intake, decisions, and behavior.

Participant voluntarily assumes all risks associated with attending Pineappless events, whether held at a public venue or private residence, including but not limited to intoxication, impairment, injury, medical emergencies, passing out, loss of consciousness, leaving the event, transportation to or from the event, serious bodily injury, or death.

**Sexual Activity & Health Risks.** Participant understands and acknowledges that attendance at Pineappless events may involve

consensual adult interactions and voluntary sexual activity. Participant acknowledges that such activity carries inherent risks, including but not limited to the transmission of sexually transmitted diseases or infections (STDs/STIs), viruses, illnesses, or other health conditions. Participant voluntarily assumes all risks related to sexual activity and personal contact and agrees that Pineappless does not provide medical screening, testing, monitoring, or guarantees regarding the

health status of any participant. Pineappless shall not be held responsible or liable for the transmission of any STD, STI, illness, infection, or related health condition.

The availability of condoms or protective items is provided solely as a courtesy and does not constitute medical advice, a guarantee of safety, or an assumption of responsibility by Pineappless.

Illegal drugs are strictly prohibited. Pineappless assumes no responsibility or liability for any injury, illness, arrest, damages, or death related to illegal drug use, possession, or distribution.

Participant knowingly, voluntarily, and expressly releases, waives, and discharges the Released Parties from any and all claims, demands, or causes of action of any kind, whether known or unknown, including negligence, to the fullest extent permitted under California law, including California Civil Code §1542.

Participant grants Pineappless the irrevocable right to photograph, film, or record Participant during the event and to use such images or recordings for marketing, promotional, social media, or commercial purposes without compensation.

This Agreement shall be governed by and interpreted in accordance with the laws of the State of California.
