Age and sex

We have 765 pupils including 84 nursery children and 82 2 year olds. Out of the 599 children in main school we have 279 female and 320 male.

We have three form entry from Year 1, Year 2, Year 4, Year 5, Year 6 and four form entry in Reception and Year 3. Our largest year groups at present are Reception with 95 pupils, Year 3 with 93 pupils and Year 4 with 90 pupils.

Disability

The lower site school built in 1997 and DDA access was taken into account when the school was designed and built. The upper site was built in 1928. An external adviser visited the school in 28th April 2015 and completed an access audit for both sites. Central Primary School has adopted this accessibility plan in line with the school's special educational needs policy with the aim to ensure that our school is socially and academically inclusive, that all pupils have access to a full curriculum, and that all pupils are appropriately challenged. The school and the Local Authority do not screen for dyslexia.

The three main SEN primary needs in school are: Speech, Language & Communication, Social, Emotional & Mental Health and Moderate learning Difficulty. There are some physically disabled pupils in school.

In accordance with the school medication policy, staff are willing to administer prescribed medication to pupils in order to ensure minimal disruption to pupils' days.
