By accepting membership with Privé Match Co., you agree to the following terms and conditions, designed to protect the integrity, discretion, and quality of the experience for all members.

MEMBERSHIP APPROVAL & ELIGIBILITY

- All memberships are by approval only and subject to screening.
- Submission of an application does not guarantee acceptance.
- Payment must only be submitted after written approval is received via email.
- Privé Match Co. reserves the right to decline or revoke membership at its discretion if standards of conduct or alignment are not met.

MEMBERSHIP STRUCTURE & MINIMUM COMMITMENT

- Membership begins with a minimum commitment of ten (10) curated matchmaking soirées, depending on the selected membership tier.
- Membership remains active until a sustained relationship of six (6) months or longer is formed, or until the included services for the selected tier are fulfilled—whichever occurs first.
- Membership is non-transferable and intended for the approved member only.

ACCESS TO CURATED SOIRÉES

- Soirée access is granted according to the selected membership level (Signature, Elite, or Concierge).
- Guest lists, venues, formats, and schedules are curated at the discretion of Privé Match Co.
- Attendance at specific events is not guaranteed and is subject to availability, balance, and alignment.
- Missed events or unused access do not carry cash value.

PERSONALIZED CONSULTATIONS & SERVICES

- Private consultations are included as outlined within each membership tier.
- Consultations are intended for reflection, guidance, and refinement of preferences—not therapy or clinical counseling.
- Consultation scheduling is subject to availability and must be used within the active membership period unless otherwise stated.

HAND-SELECTED MATCHES & INTRODUCTIONS

- All matches and introductions are curated, not guaranteed.
- Privé Match Co. does not promise a specific number of matches, dates, or outcomes.
- Chemistry, mutual interest, and relationship success are subjective and beyond the control of Privé Match Co.

MEMBERSHIP FULFILLMENT & SUCCESSFUL MATCH

- Once a member enters a sustained relationship of six (6) months or longer as a result of Privé Match Co. introductions, the membership is considered successfully fulfilled.
- Membership fulfillment is outcome-based, not attendance-based.

NO REFUNDS & SERVICE CONVERSION

- All membership fees are non-refundable.
- Unused soirée access does not convert to refunds or cash value.
- Upon successful match fulfillment, unused soirée access may be converted into private consultation services of equivalent value, at the discretion of Privé Match Co.
- Converted services are non-transferable and must be used within a defined period.

CONDUCT, DISCRETION & COMMUNITY STANDARDS

- Members are expected to behave with respect, integrity, and discretion at all events and in all interactions.
- Harassment, misrepresentation, inappropriate behavior, or breach of confidentiality may result in immediate termination of membership without refund.
- Members agree not to share private guest information, event details, or internal processes publicly.

- All personal information shared during the application and membership process is treated as confidential.
- Privé Match Co. does not share member information without consent, except as required by law.
- Members agree to respect the privacy of fellow guests and the discretion of the community.
