### Adverse Childhood Experiences

The largest public health crisis to be identified in the past thirty years. Traumatic childhood experiences (toxic stress/trauma) impact a child's daily life in the home, in school and the community. Even when children are too young to remember the events (neglect, physical/emotional/sexual abuse, abandonment, violence, etc.), the body never "forgets".

Childhood adversity affects a child's ability to learn and behave in productive ways by changing brain chemistry and architecture and thus impacts their ability to learn and behave "normally" in schools. All too often, children who are experiencing trauma, neglect and abuse in their homes and communities are identified as having "special needs," such as ADHD, when in fact it is the trauma/toxic stress in their lives that is causing the misbehavior.
