I believe that both Ms. Voyles and Mr. Arkell can explain the legal reasons for this requirement to you if you would like to understand it better.

I am sorry that you ended up in this situation. We do plan to contact all of the department chairs and deans at the university to ensure this doesn't happen again.

In my discussion with Ms. Voyles, I had the impression that she will be quite willing to work with you to change you agreement so that she can provide service on your I-485 application rather than the first two steps, but of course, that is between the two of you.
