Yes, I did go ahead and resubmitted a new permanent labor application on behalf of WIU and Dr. Koissi-Kouassi yesterday afternoon as per your request. However, I have since received your voice mail and contacted the Department of Labor today requesting the withdrawal of both applications. When I spoke with Dr. Koissi-Kouassi later yesterday she stated again that neither she nor her Department Chair was ever made aware of the university's new policy.
