
Please be advised this office has been contacted by Mr. Gilles Kouassi regarding your repeated trespass on to his property. As you are aware, Mr. Kouassi paid McClurg Engineering Associates, Inc. to complete a survey of his property on July 27, 2011. The Surveyor dropped stakes that clearly defined the property line between your properties.

Mr. Kouassi alleges that you have chosen to ignore the property line. Mr. Kouassi alleges that your failure to recognize the property line has led to the police being called on several occasions. Finally, Mr. Kouassi alleges your behavior of simply trespassing onto his property escalated to a battery when you entered his property and struck his wife with a lawn mower.

Mr. Kouassi has not given you oral or written permission to enter on his property. Instead, he has asked multiple times that you refrain from crossing over the property line on to his property.

This letter is a formal demand to take no further action to trespass on to Mr. Kouassi's property. If you are seen on Mr. Kouassi's property, the police will be notified and we will advise Mr. Kouassi to move forward and pursue all remedies under the law against you. Further, make no contact with Mr. Kouassi or his wife. Please direct any communication through our office.

A bruise or injury to the skin without a laceration.

**What you need to do:**

Apply an icepack to the affected area. Use the icepack for 30 minutes at least four times per day. Use any medications as directed by the treating physician. Bruise usually take 7-10 days to heal. Bananas and a proper diet with vitamins help shorten the healing time and can also reduce the ease with which you bruise.

**What you need to avoid:**

Avoid any activities that aggravate the injury.

**Precautions:**

Return immediately for continued swelling, increased pain, or persistent bruising without trauma. Return immediately if your symptoms change or worsen.

If you were given prescriptions: All medications should be taken as directed. Finish all prescriptions as instructed even if you feel better. Every medication may cause side effects. If an adverse effect occurs, notify your physician, pharmacist, or return to the Emergency Room. If you were given medications that may cause drowsiness, please limit your activity involving driving, moving machinery or other activities requiring concentration. Alcohol may interfere with the medications prescribed. Follow the instructions and precautions provided by the pharmacy filling your prescriptions(s).

**Imaging Studies Performed****FOOT COMPLETE RIGHT** Right

X-rays do not always show injury or disease. Fractures may not be revealed on the initial x-ray. If the problem persists or worsens, contact your physician, the follow-up physician, or return to the Emergency Room. Your initial x-ray reading is often a preliminary interpretation, done by an emergency physician to expedite your care. A radiologist reviews all x-rays within 24 to 48 hours. If there is a difference from the preliminary reading, you will be informed. If you have questions regarding the findings of your imaging studies, please call the Emergency Department at 309-833-4101. If you need to obtain copies of the films, please call the Radiology Department at 309-833-4101.
